LWV Appleton Hosts Film Screening on 'People Powered Day of Action'

APPLETON, WI — The national League of Women Voters (LWV) has designated **April 29** as a **"People Powered Day of Action"** to focus attention on the important issue of redistricting that will take place this year following release of the new census data. LWV US is encouraging local Leagues and their communities to focus with positivity and urgency on this day to make their voices heard by their elected representatives.

As part of the national observance, The Appleton League of Women Voters, with support from AAUW Appleton, is hosting a special screening of "CAN YOU HEAR US NOW?" This groundbreaking 90-minute documentary follows two unsuccessful candidates for the Wisconsin Assembly in their 2018 campaigns. By following their stories, along with other grassroots activists fighting against unfair legislative maps, the film personalizes how gerrymandering has impacted the Badger State and made Wisconsin the unsavory center of this hot button political issue.

"This film is really the story of what can happen when elected representatives stop listening to their constituents and unfairly control the political playing field," says Linda Bjella, vice president of Action for LWV Appleton. "It's also part of a grassroots effort to make sure the people's voices are heard."

Supporting the showing of the documentary aligns with AAUW's own efforts, according to Joan Moeschberger, president. "In order to move initiatives forward that benefit women, Fair Districting has become a major advocacy effort for AAUW at the state and branch levels," she says. "We are excited about working with the League on this important project."

Bjella consurs. "This support from AAUW is important because we know that the more community partners work together, the stronger our message to elected representatives will be," she says.

This special screening of "CAN YOU HEAR US NOW?" can be viewed at any time between Sunday, April 25 and Thursday, April 29, and will culminate in a virtual panel discussion from 6:30 to 7:30 p.m. that Thursday — MORE —
