**Membership:** It was decided that a potential member would receive the Bulletin for three months. After three months, another invitation to join the League would be made. **Action:** Jan, Corin, Helen, and Beth scanned the county and city budget. Jan crafted a statement which was presented at the city and county Board meetings.

**Program:** Winnie will facilitate the website meeting. Jan Quinlin will explain and help navigate the state and national sites. Susi Alger will oversee the local site.

**Observer Corps/Voters Service:** Shirley Adams has been able to fill many of the observer positions for the School, City, and County Board Meetings.

Shirley reported on the state "Issues Briefing" which she attended Oct. 15. She found that the state action alerts were informative and gave members the opportunity to contact their legislators on issues.

Smoking Ban: There was a discussion about providing a forum for the smoking ban issue. Voting on the Smoking Ban Referendum will take place in April. Shirley will call the Post Crescent to discuss a possible forum. Beth stated that we could entertain other avenues such as using Channel 4 or putting something in the Post Crescent.

Local lobbying efforts: Shirley stated that the State League Legislative Committee sets up the agenda of items which they will lobby.
