Natural Resources/Sustainability: Leslie reported a surprise move by the City Council to approve \$10,000 for the Sustainable Fox Valley neighborhoods initiative. The council was persuaded by attendance and input at the meeting from Leslie and many other concerned citizens.

Membership: Stephanie is updating the membership list for the annual meeting. She is also working on a photo board to display at meetings. The Board discussed a scholarship membership for one year to Amy Oberg who spoke at our first Food For Thought luncheon.

#### Voter Service:

- Irene reported on the completion of vigorous voter registration assistance in the recent election cycle. More than 160 voters were assisted with the help of the League at various locations. This effort included the help of several people who are not League members.
- Irene also reported on a successful mayoral candidate debate. 138 people attended the AASD candidate debate and 97 attended the mayoral debate.
- Irene is investigating a LWV voter registration assistance booth at the Appleton downtown farmers market.
- Irene is speaking June 19<sup>th</sup> at the Rotary.

Local Study: Carolyn reported the US Senate passed a bill that allows a 2 year extension on funding for mass transit. The House has not voted on this yet, but House members are advocating a 5 year extension. Penny Bernard Schaber will reintroduce an RTA bill in the State assembly when the State legislature resumes.

Program: In Sara's absence, Shirley reports that the deadline for annual reports from Board members is April 17. All required information for members (Proposed Budget, Nominees, and Recommended Program) was sent in the April newsletter.

Communications: Barb will submit mockups for a new newsletter at the next Board meeting. A table of contents for the newsletter will be included in the email.

Observer Corps: Marlys reports the dates for May Observer Corps, but the dinners will not be scheduled in May.
