Discussed changing policy term to 7/1/2023 - 6/30/2024 (fiscal year). Quote from Lisa Johnson Agency is \$1401 (budgeted \$1250). Diane made a motion to accept the policy and change the policy dates to 7/1/23 - 6/30/24, Jan seconded the motion. All were in favor, and no abstensions; motion carried.
