The League is sponsoring a presentation, Building a System-Wide Framework Using Evidence-Based Decision Making in the Justice System, by Judge John Des Jardins of Outagamie County Circuit Court Branch VII and Bernie Vetrone, Director of Criminal Justice Treatment Services . It is scheduled for Thursday, May 5, 2016 at the Appleton Public Library, Room C. Members and friends of the League are encouraged to attend.

Social science research suggests the justice system in the past has endangered community safety and increased criminal

recidivism by not focusing on proper criminogenic needs and risks when detaining and sentencing defendants.

With the help of the National Institute of Corrections, a broad-based group of citizens in Outagamie County is working on a plan to change the way persons are processed, evaluated, treated and incarcerated in Outagamie County. Judge Des Jardins and Mr. Vetrone will share the group's findings and next steps to improve the justice system. Outagamie County is one of 18 counties nationwide selected by the National Institute of Corrections for this project.



The local study committee has been meeting regularly since November 2015. The Committee has narrowed the focus of the study from Urban Policy and Land Use Planning to <u>Downtown Appleton</u>.

Coincidentally, and to our advantage, the city of Appleton began its process of updating the 2010-2030 Downtown Comprehensive Plan (adopted in 2010). The intent of the update is "to create a shared vision for the City's future". We were fortunate to come in at the beginning of the updating process and have been actively engaged, attending meetings and consulting with city employees and stake holders.

# Voter Services Update Voter registration, candidate forums, & Juneteenth

Voter registration assistance is on-going and we had a busy month in March. In the week of March 7-14, the team *helped 163 citizens send in their registration*, provided forms for eight others and information about registration and voting to 13 more.

We also held a candidate forum on March 15, with candidates for District 4 and District 8. There were 55 in attendance, and 109 attended the mayoral forum that followed. The *Voter Guides* from the questions generated at the forum were posted a week before the last election.

There is much more to do! We hope to have voter registration activities throughout the summer and into October. We should have a presence at Juneteenth, which is June 19, at City Park, from noon to 6:00. I will make arrangements with the organizers if I get five to six volunteers to work that date.

With sufficient volunteers, we could also do weekly or monthly registration assistance sessions in conjunction with *Unidos Por un Futoro Mejor-Fox Cities*. It is important to set up regular opportunities so that people can get them into their schedules—it would be great to set up a consistent night at the library. If you are interested in helping out with this, I will set up training sessions.

## Five reasons I love working with League members

Penny Robinson—Legislative Director

1. I learn amazing things the League does.

Before joining the League of Women Voters I had no real understanding about what all the League does. Originally I joined because I heard LWV had done a study of a Regional Transit Authority, which was related to the work I was doing with ESTHER.

Gradually I became aware of the full gamut of League activities, including the complexities of registering to vote and the new Voter ID requirement. I learned that the League trains us to be *Election Observers*, which I consider a special privilege and

responsibility. I have also found the educational presentations VERY interesting, but what I enjoy most is meeting these educated and informed women who care deeply about our democracy and our community.

I also had no idea about the Observer Corps but understand that we can't really have a transparent local government if someone isn't there to observe what the Common Council, the County Board of Supervisors, and the Board of Education are doing.

2. I meet amazing women who work locally and at the state level. As legislative director, I

needed to learn about legislation of interest to us, so I joined the LWVWI Legislative Committee, and then I began to see many of the ways the League is active locally and at the state level. I had no idea that the Executive Director and committee members followed the budget and dozens of bills, and made the League's positions known in a variety of ways: registering to support or oppose bills, writing letters and opinion

editorials, testifying at hearings, and calls to action. The League also collaborates with other groups and occasionally joins in a lawsuit.

**3.** I am learning about the power of the national network. The League at the national level has even more power, considering the support of leagues from all over the country. Earlier this year, members of our Appleton League worked on consensus questions for the national study on *Money in Politics*. I am beginning to see how important my annual dues are, not only

to support our local league, but the whole network.

4. I am learning how relevant the League is locally. I might not have known about the current Mobility Study (downtown Appleton) and the work to update the Appleton Comprehensive Plan if I weren't participating in the current study. The flow of downtown auto traffic as well as bike lanes and access to the Fox River are of interest to most of us.

I am very aware that we all struggle with balancing our active life in the community with personal and family needs. My number one struggle is prioritizing

and creating balance in my life, but I try to look for the greatest need.

**5. You give me hope**. Sometimes it's easy to become discouraged, but getting to know other members who are well informed and care about our local community, good government and democracy, gives me a lot of hope. Being able to contribute my little bit energizes and inspires me.

LWVUS Convention 2016 to recommend program and updated position

## Campaign for Making Democracy Work and Money in Politics

LWVUS Update, April 14, 2016 (Excerpts) Elizabeth McNamara, President

Coming out of our spring meeting, the national Board is announcing the program for the upcoming biennium – Campaign for Making Democracy Work® – that will be recommended at Convention 2016 and also announcing an updated position on Money in Politics that will replace our current Campaign Finance position. Over the coming weeks, we will post the report of the Bylaws committee and the full LWVUS Budget that will be presented at Convention. As part of that Budget, the Board is recommending no increase in the Per Member Payment (PMP) which will remain at \$32.00 for the biennium....

This has been a busy biennium. In addition to the important work that the League does in every election and the dedicated effort in every state and locality to influence policy through



education and advocacy, League members have completed a study of the process of amending the U.S. Constitution, an update of our position on Money in Politics and provided input to a task force on redistricting that has resulted in a recommended concurrence at Convention which will allow all fifty states to work for essential reform.

# PROGRAM FOR 2016-2018

The LWVUS Board recommends a League-wide Campaign for Making Democracy Work®.

This comprehensive program would build on our accomplishments as part of the 2014-16, Key Structures of Democracy Program. It would engage Leagues nationwide in advancing core democracy issues.

- Voter protection and mobilization
- Election reform
- Money in politics, constitutional amendment and redistricting

including Concurrence on the Floor of Convention with the Redistricting position proposed by the LWVUS Redistricting Task Force:

#### **LWVUS Position on Redistricting (Brief Summary)**

Support redistricting processes and enforceable standards that promote fair and effective representation at all levels of government with maximum opportunity for public participation.
