CALL TO ACTION—ATTEND CITY MEETING OCT 9

Mark your calendar to attend the Parks and Recreation meeting, Monday, Oct. 9 at 5:30 PM at City Hall to support the Climate Change Resolution—found elsewhere in this newsletter.

Bob Baker, City Council Alderman District 9, has introduced a resolution for the Appleton Common Council to work towards our own climate change plan. This is similar to what other communities are doing because of President Trump pulling out of the Paris Accords.

The resolution went to Mayor Hanna's office to determine what is already being done to support the resolution. The resolution was then sent to the Parks and Recreation Committee, which voted on Sept. 11 NOT to recommend it.

For about 90 minutes on Sept. 20, almost two dozen Appleton residents (including LWV President Jeanne Roberts) made public statements advocating for or against the resolution. Most were in favor.

This action plan would also commit to exploring the potential benefits and costs of adopting policies and programs that promote the long-term goal of GHG emissions reduction while maximizing economic and social co-benefits of such action.

The League of Women Voters has a longstanding commitment to improving the quality of life of our citizens, which includes improving the quality of our environment. The League of Women Voters-U.S. has stated that "climate change is the greatest environmental challenge of our generation."

The League of Women Voters has been at the forefront of the environmental protection movement for decades, consistently supporting

legislation to preserve our nation's natural resources and protect our public health. We support legislation that seeks to protect our country from the physical, economic and public health effects of climate change while also providing pathways to economic prosperity.

Chris Carson, LWV-US President, stated in June of this year that "Withdrawing from the Paris Climate Agreement is a giant step in the wrong direction for the health of the planet and all living beings...the long-term effects of this decision will make more people sick, especially children and the elderly."

CLIMATE CHANGE RESOLUTION

Note: Below is the resolution submitted by Bob Baker, which the Common Council returned to the Parks & Recreation Committee.

WHEREAS, consensus exists among the world's leading climate scientists that global warming caused by emissions of greenhouse gases from human activities is among the most significant problems facing the world today; and

WHEREAS, documented impacts of global warming include but are not limited to increased occurrences of extreme weather events, adverse impacts on ecosystems, demographic patterns and economic value chains; and

WHEREAS, responding to climate change provides communities an opportunity to access first mover advantage in a range of products, services and know-how that transitioning to a climate compatible future brings; and

WHEREAS, the Paris Agreement resulted in a commitment from all but 3 nations to take action and enact programs to limit global temperature increase to less than 2 degrees Celsius, with an expectation that this goal would be reduced to 1.5 degrees in the future;

NOW, THEREFORE, BE IT RESOLVED that the City of Appleton, Wisconsin

- 1. Indicates its commitment to reducing GHG emissions through future implementation of a Climate Action Plan; and
- 2. Join other US cities in the Climate Mayors network in adopting and supporting the goals of the Paris Agreement; and
- 3. Commits to exploring the potential benefits and costs of adopting policies and programs that promote the long-term goal of GHG emissions reduction while maximizing economic and social co-benefits of such action.
- 4. Form a Climate Change Board, to be filled by citizens of Appleton, city officials, and city staff to help set these goals and policies.

LWV-WI Calls on U.S. Supreme Court to Rule in Favor of Fair Voting Districts

MADISON – The League of Women Voters of Wisconsin joined other organizations this week in filing an *amicus* brief in the U.S. Supreme Court in the case *Gill v. Whitford*, the case in which a federal district court ruled the Wisconsin Assembly districts unconstitutional based on partisan gerrymandering. The brief calls on the Supreme Court to uphold a lower court ruling which requires the state legislature to redraw the voting maps in time for the 2018 elections. The brief can be found here:

The *amicus* brief demonstrates how Wisconsin's 2011 redistricting has resulted in legislation that is much more extreme than would be expected from a more typical shift in the majority from one party to another. By creating "safe districts" in which a particular party is assured of victory in elections, the gerrymandered districts insulate lawmakers from accountability to their constituents.

"We have seen a serious breakdown in the legislative process in recent years. We have seen a bill that appeared to be traceable back to the desire of one wealthy donor. We have seen cases where thousands of constituent calls and emails were simply ignored. This is running roughshod over democracy," said Andrea Kaminski, Executive Director of the League of Women Voters of Wisconsin.

The brief demonstrates the ill effects of gerrymandering specifically on legislation related to government accountability, funding for public education and protection of our natural resources. The League holds positions in all of these areas and is active in the State Capitol working to pass policies that are responsive to the

"Where the majority party used to have to seek a bipartisan consensus to get legislation passed, now it can introduce and fast-track bills with no support from the minority and only the minimum required opportunity for public input. We are urging the U.S. Supreme Court to end partisan redistricting so that every citizen's vote will have equal weight," Kaminski said.

As a nonpartisan organization, the League of Women Voters of Wisconsin has long held that voting maps should be drawn by a nonpartisan entity, rather than by the legislators themselves. The League's position, which was adopted by our membership in the 1970s, lined up with that of the Republicans in the 1970s and now with the Democrats. Our position has not changed substantially in that time; all that has changed is which party is in power in the state legislature.

As you know, Erin very ably led the League's *Gear Up to Vote* tour and election observation program last year. This year she is helping local Leagues transition to the new voter registration system and improve their online presence. I was thrilled when Erin said "yes" to the Exec Director position, and we are glad to

have the rest of this year for mentoring and transition. Erin will do a great job of building on the League's legacy and the strategic advances we have made here in Wisconsin in recent years, while also positioning the League to do even more in its second century.

Please don't fear that the great work Erin has been doing for local Leagues will go away. We are committed to that work, and we will hire another person for the Voter Education position later in the year.

By the way, I won't be going far from the League myself. I plan to serve my full 2-year term as Board Secretary, which expires June 2019.


