About Ms. Neuwirth....... Jessica is an international women's rights lawyer and activist. She is one of the founders of the ERA Coalition, mobilizing a renewed effort to get the Equal Rights Amendment into the United States Constitution. To aid this effort, she has also written the book <u>Equal Means Equal</u>, <u>Why the Time for the ERA is Now</u> which has been turned into a documentary film by the same title. Jessica is also one of the founders of Equality Now, an international women's rights organization established in 1992, and the Founder and Director of Donor Direct Action, an effort to support women's rights organizations around the world. In September 2018 she was appointed by Hunter College as Distinguished Lecturer and Rita E. Hauser Director of the Human Rights Program at the Roosevelt House Public Policy Institute.

Jessica holds a J.D. from Harvard Law School and a B.A. in History from Yale University. She has a rich history working for human rights organizations ranging from Amnesty International to the UN Office of the High Commissioner for Human Rights. Jessica has also taught international women's rights at Harvard Law School as a guest lecturer.

Wells-Barnett Museum in Holly Springs, Mississippi.

A Lively Day

About 40 members and guests crowded into Room C at the Appleton Public Library (APL) for our annual Lively Issues meeting on Saturday January 11. Our president Jeanne Roberts welcomed everyone with a long list of our League's upcoming events and efforts, plus informed us of state and national actions. We are busy!

Jill Mitchler, study committee co-chair, gave us a brief overview of the current study on Climate Change Preparedness. Her committee has been meeting almost weekly since July, and they have divided the study into two phases—see her article elsewhere in this newsletter. They will hold their Consensus meeting on the first phase of work on Saturday February 8 from 10-12 in Room C of the APL.

Then after providing a short description of the LWV process from Lively Issues to Position & Advocacy, Irene Strohbeen invited everyone in attendance to offer one topic for a study, an educational program, or for League action. A total of 30 topics were generated, and the members prioritized the following issues to be addressed in the upcoming year:

- 1. Advancing Racial Equity:
 - a. Racism as a public health crisis
 - b. What's being taught in our schools as US History
- 2. Non-Partisan Redistricting
- 3. Climate Crisis
- 4. Availability of low/moderate priced housing in Appleton
 - a. Housing for people with disabilities
 - b. Zoning, permitting and other legal ways to address gentrification
- 5. Reproductive health care
- 6. Social isolation & belonging; Strengthening our Community

Irene will take these items and prepare a recommendation to the board on what we can do with each of these topics. The proposal will then be discussed at our Annual Meeting on May 14 (5:30-9:00 at Pullman's).

League of Women Voters Appleton's Climate Change Preparedness Study Jill Mitchler, Study Committee co-chair

Most League members know that the LWV US has already approved a position statement on climate change for protection of public health and the overall integrity of the global ecosystem. The national LWV has also approved a resolution recognizing the importance of policies that align with current climate science, as well as resolutions in support of carbon pricing to reduce emissions, improve energy efficiency and to replace fossil fuels with renewable energy fast enough to avoid serious damage to the climate system.

In addition to advocating nationally for policy solutions that will slow climate change and thereby reduce the worst impacts of global warming, we are already witnessing some of the effects of climate change. The League of Women Voters – Appleton has chosen to begin an indepth study on local levels of climate change preparedness. The study committee consists of about eleven league members who've been working together almost weekly since our Annual Meeting last May. The team has conducted over a dozen interviews with local experts and elected officials to learn about the roles that local government and other organizations play in preparing for, and responding to, chronic stresses and acute emergencies from extreme and unpredictable weather patterns.

LWV Studies typically continue for two full years, with the final position statement presented for Board approval at the end of that period. However, this study committee decided to break their work down into two phases: the outcome for the first year is a general position statement, and the year two outcome will be a more detailed statement with specific recommendations. The team is looking forward to sharing the information they've gathered thus far at their first consensus meeting on February 8 in Meeting Room C at the Appleton Public Library. Next year at this time, the team will conclude their study with a proposed position statement that recommends more specific guidance to assist in local advocacy for climate change preparedness.

19th Amendment Centennial Kickoff Celebration

On a dreary Saturday morning, a packed crowd at the Fox Valley Performing Arts Center enjoyed good food, great comradery, and fantastic speeches at the 19th Amendment Centennial Coalition's kickoff celebration. The words of our key note speaker, Dr. Sally Roesch Wagner, Founder and Executive Director of the Matilda Joslyn Gage Center and suffrage historian, invigorated all those who heard her. Many thanks go out to all who were involved in making this event so memorable.

Traveling Exhibit



A **Traveling Exhibit**, developed by the <u>Wisconsin Historical Society</u>, is available for limited display at locations throughout the Fox Valley. The eight-panel display, <u>"We Stand on Their Shoulders": A History of Wisconsin Women and Voting</u>, explores moments when women in Wisconsin gained political rights and highlights a few key leaders.

Covering the ratification of the 19th Amendment, 1921 Wisconsin Equal Rights Act, 1924 Indian Citizenship Act and 1965 Voting Rights Act, the display shares the important story of women's quest for political rights and recognition through quotes, photographs and a timeline of events. Volunteer to Be an Election Observer

Help the League of Women Voters of Wisconsin monitor Wisconsin's elections. We are seeking volunteers to be trained as Election Observers and placed in polling places in specific areas around the state. We provide training, assign volunteers their polling place(s) to observe, and provide volunteers with a reporting form to record their observations. We will do our best to assign you to a location near your home. You don't need to be a League member to volunteer for this -- although we'd love to have you join us!

For the 2020 elections we are focusing the Election Observation Program in three areas:

- 1. to be sure there is no disenfranchisement
- 2. to monitor the voter experience including registration and showing ID
- 3. to track any problems that can be fixed for future elections


Requirements: You'll need to be available to volunteer for a minimum of 2 hours on Election Day. Election observers will also need a cell phone to use while volunteering and have their own transportation to and from their assigned polling location. There are also opportunities to be a "roving" observer and observe at multiple polling sites. Rovers need to be available to volunteer for at least 4 hours on Election Day. **Training Information:** We conduct our election observer training via online webinar.
