Fight for Fair Maps: A long, hard road lies ahead

Here's the good news: 54 of Wisconsin's 72 counties have weighed in on the issue of non-partisan redistricting, and there are 9 more counties with referendums on the ballot in November. Average support for fair maps across the state has been 72%. Clearly, people in Wisconsin do not like gerrymandering. In a recent Marquette University poll, 83% of Democrats, 76% of Independents, and 63% of Republicans favor fair legislative maps.


The bad news is that all this grassroots support is advisory only. Unlike some other states, Wisconsin's Constitution doesn't allow for binding resolutions generated by citizens. In order to stop gerrymandering in Wisconsin – the most extreme case of partisan gerrymandering in the country – our legislators have to be persuaded to end it. Prying loose a party in power is not going to be easy and it's not going to be quick.

I recently had the opportunity to attend (virtually, of course) a program on fair maps with Jay Heck, the executive director of Common Cause in Wisconsin for the past 22 years. Here's what he predicts will happen with redistricting after the census.

Republicans will retain control of the legislature after the November election. Current legislative maps guarantee this will happen. According to the Wisconsin Constitution, every 10 years after the census, the legislature "shall apportion and district anew the members of the senate and assembly, according to the number of inhabitants." Notice it doesn't say the legislature "shall draw the legislative districts."

Packed and Cracked

This certainly isn't what was done in 2011 with the current maps. A highly secretive team headed by a political operative from Oklahoma began meeting behind locked doors in an office building across from the state capitol. Using partisan voting data and computer algorithms, the previous legislative districts were "cracked" and "packed". Democratic voters were packed into small districts (like the 57th) and others were cracked and sprinkled into majority



were cracked and sprinkled into majority
Republican districts (like the 55th and 56th). The result? No matter how many people vote in an election, Republicans are mathematically guaranteed at least a 59% majority in the legislature. The 2018 election proved the point: 54% of the voters favored Democrats, but won only 36% of the legislative seats. Not a single Republican lost, and 38 of races were uncontested.

It's important to mention that when Democrats had control of the legislature prior to the 2010 election, they had the opportunity to put non-partisan redistricting in place and didn't do it. Also worthy of note is that other states such as Maryland have been severely gerrymandered by Democratic politicians.

Heck predicts that the Wisconsin legislature will draw similar partisan maps in 2021. Governor Evers will veto them, and without a 2/3 majority to override the veto, the matter would ultimately be resolved by the Wisconsin Supreme Court ,which has a 4-3 conservative majority. The process will end there because the U.S. Supreme Court has ruled that partisan gerrymander cases will no longer be addressed by the federal courts.

Another even more nefarious scenario is a scheme to circumvent the governor altogether, and pass the new legislative maps as a joint resolution which is not subject to a governor's veto. This was tried once before in 1960, and the Wisconsin Supreme Court ruled it was unconstitutional. Would the current Wisconsin Supreme Court abide by that decision? Remember that these justices are elected for 10-year terms, and may be influenced by strong public opposition to partisan gerrymandering. This is why grassroots activism is crucial. Hustle is a peer to peer platform. LWVWI supplies volunteers with a list of Text numbers. You can generate the text from a pc, smartphone or tablet device. If your text generates a question, you can respond directly with that person. LWVWI will provide training on how to use the app. Once you're trained, the volunteer schedule is very flexible.
