What a month! We have learned much as a League, including how much more help we really could use from our members.

Special thanks to Dave Strange for the incredible amount of work that he has done and Barbara Kelly for being his backup tech person for the candidate forums. We were able to reach almost 3,000 people by utilizing Zoom for the forums!

Given the current situation with Covid-19 our League will need to continue doing our work to Empower Voters and Defend Democracy using a virtual format. That means we will need people to volunteer to learn about the technical assistance that is needed, including how they can help with candidate forums, social media, monthly programs and all of the other work that we are doing. If we can get enough volunteers, it will not require nearly as much time for any of us.

We have been doing an incredible amount of work at the local, state and national levels, especially with our focus on voting safely. The Wisconsin Elections Commission (WEC) reports that 1,286,494 have already requested an absentee ballot in Wisconsin! The LWV US has been filing lawsuits to eliminate efforts at voter and census suppression and they have had some success.

The LWV Appleton also has been focused on voter registration education and assistance focused on voting safely, including providing assistance for those who want to complete an absentee ballot but need a witness. The media has noticed our good work and has turned to the League to provide the nonpartisan, fact-based information that it has been known for since February of 1920.

Thank you to everyone who has been a part of this incredible journey!

In this last issue of *The* Informed Voter for 2020, the Board thought it appropriate to highlight the amazing amount of work, programs, voter outreach, study and advocacy that our members have successfully carried out in this most challenging year. So along with all of the informative content in this issue, we have devised a timeline that we hope displays the volume and depth of our work and accomplishments during a time when we had to rethink and reimagine all of the ways we connect with each other and with our community. Any oversights are purely accidental and in no way intentional. Thank you to all who contributed in any way to this incredible body of work.

League Powers Long List of Advocacy Issues

As we celebrated the 100th birthday of the League's founding on February 14, 1920, we held a "Power the Vote" event at the Appleton Public Library to encourage our members to contact representatives. There was a long list of advocacy items that Leaguers responded to this year:

National action items:

- •Support for "For the People Act", the first comprehensive piece of legislation passed by the House of Representatives following the mid-term election in 2018
- Support for legislation which would eliminate the deadline for ratification of the Equal Rights Amendment
- Support for legislation that would restore the provisions of the original Voting Rights Act of 1965 and provide greater transparency and voter protection
- Oppose shortening of the census
- Oppose budget cuts and other administrative changes to the U.S. Postal Service

State action items:

- •Support for Fair Maps legislation that would establish a nonpartisan commission to draw the new legislative maps in 2021
- •Support for legislation that would make Wisconsin part of the National Popular Vote Interstate Compact
- •Support for legislation that would address the crisis of missing and murdered indigenous women
- Oppose legislation that would take the focus off of rehabilitation and restoration to reduce Wisconsin's prison population
- •Oppose legislation that would result in increased criminalizing of juvenile offenders
- •Support for legislation addressing gun violence
- •Support for safer-at-home and mask mandates policies to control the pandemic
- •Support for the People's Maps Commission

Local action items:

- •Support for funding of Diversity, Equity, and Inclusion (DEI) positions for the City of Appleton and Outagamie County
- Support for the Emergency Manager position for Outagamie County
- Support for the Conversion Therapy Ban at the Appleton Common Council Meeting
- •Support for the County's Comprehensive Plan
- •Support for the Hmong community and against deportation
- •Support of a resolution to have mailed ballots in Appleton after the spring election
- •Spoke on racism and health care outcomes
- Spoke at both city council and county budget hearings
- Support of the library
- Support of the Climate Committee's Recommendations
- Support for the Parks & Rec Department budget as a need during COVID
- •Support to thank the Health Departments and both city and county clerks
- •Obtained mayoral proclamations recognizing the LWV and 19th Amendment centennials and in favor of fair maps

Observer Corps:

We now have teams of observers tracking the Appleton Common Council, the Outagamie County Board, and the Appleton Area Board of Education and have put in place a procedure that observers can use to report to the board. Going forward, we want our observers to examine everything through a DEI lens in keeping with the importance of that initiative for the LWV.

2020: Nevertheless, We Progressed!

Typically, we provide reports at our annual meeting about what we have done, but this year has not been like any year in recent memory. We decided to do a fun review of all of the programs, voter registration, celebrations and especially changes that we had to make last year in order to make 2020 an incredibly successful year for LWV Appleton.

We began our year in December of 2019 at the Performing Arts Center with a celebratory kickoff to the centennial of the passage of the 19th Amendment with Dr. Sally Roesch Wagner speaking on the influence of the indigenous women on the early suffrage movement. In January we conducted another successful Lively Issues meeting and agreed to continue with the second year of our two-year study on climate change preparedness. We also began our work on the census.

In February, we welcomed along with the other centennial committee organizations, Jessica Neuwirth to speak about the Equal Rights Amendment. In early March, the centennial coalition welcomed Michelle Duster, great-granddaughter of Ida B. Wells to talk about the work of the African American Suffragists.

Along with all of the programming, we conducted several successful candidate forums and voter registration assistance events.

And then everything stopped. In order to continue to fulfill our mission to Empower Voters and Defend Democracy, we had to completely change how we did everything. The pandemic caused closures and restrictions that would not allow for our usual face to face advocacy.

LWV Offers Ways to Engage, Help Out

LWV is always looking for good people to help fulfill our mission to Empower Voters and Defend Democracy. At the beginning of the year we will need help with the budget committee to review last year's budget and prepare for next year's. This requires a commitment of one afternoon for 2-3 hours. Volunteers need not have math or budget experience.

LWV Wisconsin is looking for volunteers for an ad hoc committee to study the League's policies on young people in League and the current age restrictions. This would involve Zoom or GoToMeeting meetings with other League members around the state and would be a great opportunity to meet other people and learn a little about the inner workings of League.

Moving forward, LWV will be looking to create a technology committee to assist with the incredible increase in our technology needs. Volunteers need not be IT experts, but only have some basic computer skills and a willingness to learn. The committee would develop an overall tech and social media plan including the areas of:

- Social Media
- Voter Registration
- Candidate Forums
- Special Events lively issues, holiday brunch, annual meeting, etc.
- Monthly Programs
- Website
- Ad hoc requests example: converting PowerPoints to videos and posting on YouTube
- Simple video editing
- Finding, evaluating, and acquiring software appropriate for projects after listening to people planning them
- Mailchimp or other email support
- Monitoring League emails

Voter Services Meets Its Mission Amid Pandemic

This was a challenging year for our team. With mayoral and presidential elections on the slate, we had very high voter interest and were looking forward to helping turn that interest into new voters. Then the pandemic hit and shut down all of our in-person opportunities. Our team made the decision early on that any opportunities would need to be either online or both outdoors and contact-less in order to protect our volunteers and the general public.

The team worked hard, became creative, and produced results:

- Made ourselves available 25 times to the public to provide information and help people register to vote before pandemic curtailed in-person events.
- Trialed a weekly time slot at the Appleton Public Library in addition to our annual schedule at local high schools and colleges.
- Conducted 2 Voter Registration Training sessions trained 20 new volunteers.
- Helped register 52 new voters between January and March 15 when inperson activities were halted due to pandemic.
- Used a Diversity, Equity and Inclusion grant to produce short online videos featuring diverse citizens explaining voter education basics. These videos were recognized by LWV US as an example of adapting our methods to meet needs during the pandemic.
- Established an "Ambassador" network program with college freshmen broadcasting nonpartisan voter information to their peers.
- Distributed 30 "Vote From Home" yard signs. Designed and deployed sandwich board and other signs at outdoor events.
- Engaged with 2 high school seniors via Willems Marketing internship. These young women created their own brand and social media accounts to help spread nonpartisan voting information to their peers.
- Transitioned to an online and media outreach to inform potential voters on how to register. Conducted 4 radio interviews. Our high school interns appeared on local WFRV TV news to encourage voting.
- •Produced the in-person Appleton mayoral candidate forum. Produced 3 State Assembly district forums entirely online. Assisted in production of District 8 Congressional forum. The in-person mayoral forum was so popular the room was filled to capacity and we had to encourage people to watch the recording. The online State Assembly forums resulted in hundreds of people participating/viewing and were extremely successful in technical execution.

Census

Three of our LWV members served on the Outagamie County Complete Count Committee. Karen Nelson was appointed as co-chair, and Shirley Strange and Linda Bjella served on the committee.

Fair Maps:

Penny Bernard-Schaber is chairing a team that is working to pass county referendums in support of nonpartisan redistricting in the 8th congressional district. Linda Bjella also serves on this committee. In July, this group sponsored two events in downtown Appleton: a "Honk for Fair Maps" car parade, and a "Stand for Fair Maps" demonstration. The Shawano County board recently passed a fair maps resolution and Brown and Door Counties both passed fair maps referendums on November 3.

Pack the Polls:

Our LWV sponsored a car parade in October 24 on National Vote Early Day as part of a state-wide campaign led by Building Unity. The emphasis was a nonpartisan get-out-the vote message. The Lamers Company donated the trolley to lead the parade through Appleton. Other organizations that joined with the League were AAUW, CCL, Esther, Fox Cities Advocates for Public Education, Celebrate Diversity, and The Fox Valley UU Fellowship.

2020 Impacted Program Delivery

Our Diversity Committee responded by offering two special programs in the summer.

The Diversity, Equity and Inclusion (DEI) Committee influenced our League in many ways. Our October program celebrating Hispanic Heritage was presented in both English and Spanish!! We, by "we" I mean Dave Strange and Barb Kelly, learned how to make this possible. Dave and Barb continue to explore ways to make more of our programs accessible to more people. The October Hispanic Heritage Celebration program was a collaboration with Kimberly-Clark's LAND (Latin American Network for Diversity) division. Of the 55 who attended, 30 were League members and 14 Kimberly-Clark employees. Special shoutout to presenters Maria Lopez-Garcia, Norys Pina, Ligia Rivera, and Britt Wells, and a special thank you to Maria Elena DeLeon, the woman who volunteered to translate during the program. Maria is not a professional translator and she left her comfort-zone to help us reach more people in our community.

Looking forward we have our **Social Injustice in Housing program, Monday November 16, 5:30 – 6:30 p.m.** Join us to learn about our local housing issues. We will close the calendar year with our **Holiday Gathering Saturday, December 12, at 9:00 a.m.** where we'll explore Gerrymandering. Matt Rothschild, executive director of the Wisconsin Democracy Campaign, has been working on this issue for many years and will share his thoughts about the current progress toward a fair map. Rothschild wrote the book *You Have No Rights: Stories of America in an Age of Repression* and many opinion essays appearing in many national newspapers including the *Chicago Tribune*, the *LA Times*, the *Miami Herald*.

2021 starts with **Lively Issues** (**Saturdays January 23 and 30**) where we decide which issues we want our League to research and address. Our Climate Change Preparedness and Resilient Community study committee will come to an end soon and we'll decide what our League positions will be on these issues during a **Consensus Meeting** (**Saturday, February 13**). **February 15** will be an exciting exploration into how our US history is being taught and presented in public education, and on **March 15** we'll discuss reproductive health. **April 19**th we'll learn more about climate change, and conclude our year with our May Annual Meeting.

DEI Efforts Make LWV More Accessible to Diverse People

Census: Census efforts began in March, outreach to the Latinx community turned from face to face events to electronic ways of communicating in an effort to help members of the Latinx community complete census forms. Karen Nelson and Maiyoua Thao helped with the Hmong community.

MMIW - In March we began tracking legislative efforts initiated by then Rep. Amanda Stuck and Renee Gralewicz, member of the Brothertown Nation, to address the crisis of missing and murdered Indigenous women, girls, and Two Spirit individuals. Two Spirit refers to individuals who do not identify as either male or female. In June 2020, due to the advocacy by members of the 12 tribes of Wisconsin, including Renee Gralewicz of the Brothertown Nation and member of the DEI Committee, we obtained a commitment from Josh Kaul, WI Attorney General, to create a task force. The Task Force membership was announced in October; we await action.

Threat of Hmong Deportation: Long Cheng Marketplace was the location of a press conference covering the response to the threat of deportation of Hmong refugees. Many public figures presented statements and several members of the DEI Committee and other community members were present to support the Hmong community.

The Diversity, Equity and Inclusion (DEI) Committee is always working to make the League more accessible to diverse communities. In May, Technical Director Dave Strange made the **website**, <a href="https://www.nebsite.com/www.nebsite.com/www.nebsite.com/www.nebsite.com/www.nebsite.com/ww.ne

Voting: In June Ligia Rivera perused local, state, and national League websites to identify areas that needed improvement for Latinx access.

Voter Registration Assistance: In July Ligia Rivera helped the National League with their website to be more accessible to Latinx voters as well as making Vote411 easier to access for Spanish speaking voters.

Summer Social (Distancing) Series - The DEI Committee and League Membership, working with Programming, hosted a **Summer Social (Distancing) Series** in July and August. The first series entitled "Why This Time Is Different" covered topics of Systemic Racism and the intersection of policing and race. The second series, "Say Her Name" covered the issue of Black women dying in police custody along with "Missing and Murdered Indigenous Women and Girls and Two Spirits" focusing on the disappearances and deaths of Indigenous women, girls and two spirits.

Karen Nelson, Committee member and Diversity and Inclusion Coordinator for the City of Appleton, has written several thought-provoking **articles for** *Appleton Monthly*, including" Racism is a Crisis", "Yes All Lives (Should) Matter," and more. Access the articles <u>here</u>.

Voter Registration: In September and October much work was done for voter registration assistance in the Latinx community. Partnering with ESTHER and Voces de la Frontera, Ligia Rivera and Jeanne Roberts participated in setting up information tables at three Hispanic restaurants. Ligia also set up registration assistance at a Hispanic bakery where she and her colleagues registered voters, provided voter information, and even helped a young woman with information to become a US citizen. Ligia also created summaries in Spanish of political candidates for New London and Beaver Creek.

Going forward, The DEI Committee is creating action items to fit the newly created goals. We will be reaching out to League members for participation.

The Appleton LWV assembled a coalition of women's organizations which included AAUW, Midday Women's Alliance, the Northeast Wisconsin Alumnae Chapter of the Delta Sigma Theta Sorority Inc., and the Women's Fund for the Fox Valley Region. We received major grants from the Community Foundation of the Fox Valley Region and the Kimberly Clark Foundation with in-kind support from Coalesce Marketing, Fox Valley Technical College, The History Museum at the Castle, The Fox Cities Performing Arts Center, and Andee Vosters, vision navigator.

We sponsored four major events:

- December 14, 2019: Kick-off Brunch: *The Influence of Indigenous Women on Early Suffragists,* with author and professor of women's studies, Dr. Sally Roesch Wagner at the Kimberly-Clark theater of the Fox Cities Performing Arts Center

- August 26, 2020, Women's Equality Day: *Nevertheless, We Progress,* a virtual celebration of 100 years of women's rights which can be found on the coalition website: hervoicehervoteourvictory.com

In addition, we developed educational resources for both elementary and secondary students and assembled a speaker's bureau of volunteers who spoke to local groups about women's suffrage history and then moved into the virtual space to do presentations for groups across the country. We acquired a traveling exhibit, *We Stand on Their Shoulders: A History of Wisconsin Women and Voting* developed by the Wisconsin Historical Society. We provided voter information at all of our events and developed informational videos targeting underserved voting groups.

And there is still more to come!

On Tuesday, November 17 at 6:30 p.m., there will be a virtual presentation, *An Evening with Wisconsin Suffragist Jessie Jack Hooper* presented by Dr. Helen Bannan, retired Director of Women's Studies and Associate Professor of History at UW-Oshkosh. Next year, we are planning a Women's Equality Day celebration with Elaine Weiss, author of *The Woman's Hour* which chronicles the spell-binding history of the final stages of state ratification of the 19th Amendment in Nashville, TN during the summer of 1920.
