2. Diversity, Equity and Inclusion (DEI) Initiative: This project began a while ago but expect more intensive efforts to assure that our League has fully integrated the important principles of DEI, which the LWVUS has identified as important as our nonpartisan value. Voter Registration Day Results in New Partnership

National Voter Registration Day is a nonpartisan designation celebrating democracy and our right to vote. First observed in 2012, the event has gained momentum, with nearly 4.5 million voters registering on that date since its inception. Celebrated on the fourth Tuesday of September, the day is intended to create broad awareness of voter registration opportunities and reach potential voters who might not have registered otherwise.



In conjunction with National Voter Registration Day, our Voter Services Team has been looking for ways to get the word out encouraging voters to make sure they are registered. We have been at some events—outdoors and following CDC guidelines—but we wanted to find ways to connect with more people.

One of our newest League (and Voter Services Team) members is Lisa Nitecki. She has connected us with the Starbucks regional manager (thank you, Lisa!) to work with us on ways to get voting registration reminders out to their customers. The League of Women Voters of Winnebago County was excited to join us on this project.

Each of the Starbucks received table tents, wallet cards and 500 stickers to add to the cardboard sleeves for the cups (pictured above). We have reached 10 Starbucks in the Outagamie/ Winnebago County areas. Advocacy: Officials Listen When LWV Speaks

It is humbling to speak on behalf of our League to local government leaders. I have had an opportunity to deliver three statements in recent months on behalf of you, our members. Our elected officials listen when League speaks because they know that our positions are backed by years of careful research and represent the consensus of our members. This study and consensus process is unique, and it has always served our organization well throughout our century of advocating for good government.

In August, I spoke to the Appleton Area School District Board of Education in favor of a mask mandate. It was a learning experience for me to formulate the statement. It always starts with our positions. The League never advocates publicly unless we have a position to support what we say. So, I started by combing through our local positions. We don't have a position that specifically addresses wearing masks in schools, of course, but that's the genius of our League positions. They are written to be general enough to be able to apply to unforeseen circumstances.

Here was the statement:

August 23, 2021

Statement to the Appleton Area School District Board of Education on a mask mandate

The League of Women Voters of Appleton believes that one of the primary goals of a school district is to provide a safe and secure environment on every campus for all students, staff, and visitors. The League also strongly supports following public health guidelines regarding communicable diseases. Therefore, we urge the Appleton Area School District Board and administration to follow current CDC guidelines which recommend that masks be worn in all indoor settings in areas of substantial or high COVID-19 transmission regardless of vaccination status. The League's positions provide the basis for this statement. We formulate our positions after carefully researched studies that have been ratified by our membership. Thank you for this opportunity to share our positions.

And here are the specific position statements I used to support it:

Public Health Services (1986)

"Support public health services which include...communicable disease control."

Education – School Safety (1983 and 1993, revised 2006 and 2019)

"The primary goal of a school district is to provide a safe and secure environment on all campuses for all students, staff, and visitors..."

I was involved in the Education Study in 2019, and I know that our position statement was written in the context of the threat of gun violence in schools, but you can see how this statement can be used very effectively to address the threat of the pandemic as well.

Sometimes it takes more digging to find a relevant position. I made statements to the Outagamie County Finance Committee and to the full County Board in September. The first was to state the League's view on how funds from the American Rescue Plan Act should be used, and the second was on the subject of redistricting. In both cases, we were able to use local, state, and national positions to undergird our official statements. I want to especially thank our Action VP Jan Quinlan for her help in researching and writing these statements.

Virtual Fair Maps Lobby Day Draws 200+ Advocates

Over 200 citizens participated in the virtual Fair Maps Lobby Day on Monday, September 28. During the 113 legislator meetings, we used our collective voices to advocate for a fair, transparent non-partisan process for drawing our voting district maps. We proudly boast to having had 29 participants on the Senate District 19 team, the most participants of any senate district and the most well prepared, too!

Our team held four legislative meetings during which we asked legislators to:

- 1. Support and pass the nonpartisan redistricting bills that have been introduced (SB389 / AB395).
- 2. Take up the maps created by The People's Map Commission.
- 3. Reject Pro-Gerrymandering Resolution AJR80 / SJR63.

We met with Michael Donatello, Sen. Roger Roth's office (SD19), and Michael Moscicke, Rep. Dave Murphy's office (AD56). While disappointing not to have anyone in Rep. Rachel Cabral-Guevara's office (AD55) to speak with, a recording of our presentation was sent. The results of our visits with the staffers revealed that they are likely to be less knowledgeable about the Fair Maps bills than we are, and in some cases, are misinformed about the People's Maps Commission work and the goals of nonpartisan redistricting.

The day following the Fair Maps Lobby Day, all three of these legislators voted to approve the joint resolution, which supports using the current gerrymandered maps for another decade.

The final meeting of the afternoon was with Rep. Lee Snodgrass (AD57) and Fawn George, office staff, who were both in attendance. Rep. Snodgrass is supportive of all three asks and voted against the ioint resolution.

It is essential that all of us continue to pressure legislators who are resistant to Fair Maps. Attend rallies, write letters to the editor, continue to make calls and send emails to the legislators. Continue to organize and build our ranks of volunteers to educate voters and mobilize them to take action with

Needless to say, our work to achieve fair representation has only just begun. Are you with us as we continue to fight for Fair Maps?

So far, more than 20 people have joined us in conversations about the study, and we decided that we will focus our attention on area health care systems.

- Public Health/ Preventative
- Hospital/ Clinical/ Urgent Care
- Pharmacy
- Under/ Uninsured/ Access
- Medical Professionals (e.g., school nurse)
- Holistic [e.g., foods, herbology, functional medicines]
- Mental Health/ Access/ Availability
- Home care/ Long term/ Elder care
- Maternal Health/ Reproductive Health
- LGBTQ+ / Gender affirming care

Our study will assess and understand the status and practices of current health care structures, including looking at their mission statements and annual reports. We intend to contact experts in the field as well as people who work(ed) within the health care system. Additionally, we will interview those who have used or been denied access. So, you can see that there are still a lot more decisions to be made before we get to the heart of our research.

No one is going to be asked to do all of the research; we hope that you will join us in this exploration if you have knowledge of, or interest in, the study. Your help is based on your time and interest. For example, if you're passionate about health care access for homeless, you could help us out with just this area of the study. Fair Maps!

Now is the time to make our voices heard for Fair Maps. Over 80% of Wisconsin voters supported non-partisan redistricting in a recent poll. Here's what we've done recently to advocate for Fair Maps: LWV Appleton alerted members to a Fair Maps Pack the Park Rally held at Bay Beach in Green Bay on August 28. Linda Bjella spoke at a public hearing on Fair Maps and County Redistricting on September 14. On September 27, a number of our League members participated by Zoom in WI Fair Maps Coalition's full day of lobbying legislators with Ann Muenster, Carol Lenz, Linda Bjella and Jacqui Klimaszewski taking leadership roles. What's next? Please contact your state legislators and encourage them to hold a public hearing on Fair Maps legislation.

American Rescue Plan Act (ARPA)

Outagamie County hosted 9 listening sessions with frontline organizations to help determine their priorities for using \$35M in federal funding from the American Rescue Plan Act. Our League participated in 4 of these sessions, and in early September Linda Bjella sent a letter to County Executive Tom Nelson and all OC Supervisors supporting ARPA funding as per League's support positions: Safe and resilient environment; Strengthened child care and enhanced services for families in need; Adequate affordable housing; Coordination among local governments in the Fox Valley region to benefit the greatest number of people. Stay tuned for much more information as our counties and municipalities make decisions about how to use federal rescue dollars.

Mask Mandates

Our League supports mask mandates for local school districts based on our Public Health Services position: "Support public health services which include...communicable disease control," and our Education – School Safety position: "The primary goal of a school district is to provide a safe and secure environment on all campuses for all students, staff, and visitors..." Linda Bjella presented our League statement on mask mandates to the AASD Board of Education on August 23. A number of our members also participated in a pro-mask mandate rally outside the school district offices on August 23. Ann Muenster and Jan Quinlan's photo was on the front page of the Post-Crescent and later USA Today following that rally.

Jan Quinlan has recruited 14 of our LWV-Appleton members who are active in local government issues to serve on the Executive Action Team. These members will alert Jan to emerging issues in our community, and in turn Jan will work with League leaders to take action. Turn the Member Spotlight on Miriam Douglass

First, a short bio. I grew up in Orono, Maine where my father was a professor of chemistry at the University of Maine. He inspired my interest in chemistry, as he let me dabble in his lab and later employed me on his summer research

projects during high school and college.

My mother was a piano teacher and choir director and encouraged me in playing the violin. Our high school had an amazing music program for a small school (43 graduated in my class), and I played in the orchestra (violin) and band (sousaphone) and sang in the choruses.

Sports were also a big part of my life. My friend and I organized and coached a basketball team when the gym teacher and boys' coach would not (that was before Title IX). We had a hard time getting practice time in the new gym until my mother convinced the Superintendent that our taxes had paid for the gym and we deserved access. In the spring I played softball and in the summers participated in the various sand lot baseball and football games going.

I went to Oberlin College where I majored in Chemistry, then on to Northwestern University for a Ph.D. in Organic Chemistry. My career was spent as a research chemist at the Colgate-Palmolive Co. Technology Center in Piscataway, NJ, where I met my future wife, Ligia Rivera. I also taught chemistry as an adjunct professor at Rutgers University and later at Fox Valley Technical College after I moved to Wisconsin.

The League has been a big part of my life for over 50 years - the first 33 in New Jersey and

later here in Appleton, where I moved in 1999. Many of my best friends - women and men - I met in the League, where we shared study and action on many interesting and important societal issues. The recent study of Climate

Change Preparedness has been a fascinating part of my life over the last two years. Having my wife on the study committee added fun conversations to the effort. The current promise of a new library in Appleton also is rewarding after our 2012-2014 League study and support position.

In New Jersey, because of my technical background, I chaired the National League study of hazardous waste disposal which led to support of the federal Resource Conservation and Recovery Act (RCRA) of 1976. This study led to two significant local outcomes for me. Our Piscataway League was a major force in preventing the building of housing on land contaminated by toxic chemicals and which later became a Superfund site. I realized that RCRA would force a 180-degree change in disposal of lab chemicals. This led me to develop a new cradle-to-grave chemical management system which was implemented in the research center where I worked.

Some other things I love to do are travel, be outside walking or working in the garden, play the recorder with two ensembles, attend musical concerts and read. A favorite book is "Timefulness - How Thinking Like a Geologist Can Help Save the World," by Lawrence Professor Marcia Bjornerud. It has been very helpful to me in developing perspective in the midst of our human-caused climate crisis.
