League Airs AASD Candidate Interviews

The Appleton League of Women Voters has recorded interviews with each of the nine candidates who will appear on the February 15 primary ballot for the Appleton Area School District Board. Previously, the League provided live candidate forums via its website and live streamed on its Facebook page. Given the number of candidates on the primary ballot, the individual interviews were recorded ahead of time and may be viewed any time.

Questions that were posed to each of the candidates came from League members, the public, and students in the Appleton Area School District. Each candidate was asked the same questions, and given the same amount of time to respond to each. Appleton's Climate Task Force meets our own

The City of Appleton's Climate Task Force presented its final report to Mayor Woodford and the Common Council on Wednesday January 19, 2022 following two years of research and planning. Our League Climate Task Force also spent two years on this important and timely local study which culminated in detailed and extensive support positions we will use to advocate for climate adaptation and resiliency.

<u>Our League's public statement on Climate Resiliency</u> applauded the City Task Force's recommendations but encouraged higher prioritization for social justice especially for those in our most vulnerable populations. Extreme climate crises will demand collaboration and cooperation across all local government units for effective swift responses that can save lives. Thanks to Ligia Rivera and her committee for crafting this statement and for their continuing research on these crucial issues.

Fair Maps Rally at Houdini Plaza braves the weather

The bitter cold couldn't stop about 50 advocates for Fair Maps from rallying at Houdini Plaza on Friday January 21. LWV Appleton-Fox Cities Co-President Linda Bjella delivered a <u>strong non-partisan</u> <u>statement at the rally</u> describing how gerrymandering takes away the power of our votes and our voices which weakens our democracy. Our League co-hosted this event with a number of other organizations including the Wisconsin Fair Maps Coalition. Our goal was to join with 15 other rallies across the state to let our Wisconsin Supreme Court know that over 80% of Wisconsin residents support Fair Maps and a non-partisan process for redistricting.

Black Women Helped Win Voting Rights for All Women

February is Black History Month, so we decided to spend a little time celebrating just a few of the strong Black women who have helped all of us win our rights, but who have not gotten the credit due to them. I'm going to highlight the lives of six Black women who worked to assure our right to vote.

Frances E.W. Harper was a prolific writer and abolitionist who became known as the "bronze muse". She later became one of the most articulate advocates for women's rights, racial equality and temperance.

Lucie Wilmot Smith promoted woman suffrage in the Black press and the Black community during the late 1800's. She was a faculty member at the University of Louisville and wrote articles that were often reprinted, and kept women's equality and related issues before Black readers throughout the country.

Strong Black Women Helped All, continued

Maria Louise Baldwin was a widely admired teacher and club woman who promoted equal rights. At age 33 she became the principal of the interracial Agassiz Grammar School. The president of Harvard, Charles Eliot, called her the best teacher in New England.

Naomi Talbert Anderson was considered one of the strongest Black voices in the woman suffrage movement during the late 19th century. A pioneer within the Black women's club movement, she believed that "woman has a power within herself."

Adella Hunt-Logan was an educator and writer who organized suffrage activity among Black women at Tuskegee Institute. In 1913 she encouraged Black women to march in the suffrage parade in Washington, DC after reading that it was to be segregated, and believed that one reason that Black women should try to organize other Black women was that white women were never going to do it.

Verina Morton-Jones was a pioneering physician and a leading club woman in Brooklyn. In the words of historian Thea Arnold, Morton-Jones "fought to win the vote for all women and fought to protect the right to vote of all Black Americans". *****

My friend Karen once told me that Black women fought for all women's right to vote knowing that this right would not apply to them. And it wasn't until the Voting Rights Act of 1965 that Black women and other women of color actually had their right to vote protected. Right now, voting rights are seriously under attack and it is up to us to make sure that those attacks don't succeed.
