VOICE of the LEAGUE: Setting the Record Straight

A recent article concerning candidate forums for the 19th State Senate district included a comment by Rachael Cabral-Guevara indicating why she did not participate in the League of Women Voters forum. "What I'm opposed to is the dishonest manner in which LWV presents itself to voters," Cabral-Guevara said. "In good faith, I can't support something that tries to pull the wool over the eyes of voters."

While Ms. Cabral-Guevara is certainly free to accept or reject any invitation to connect with voters, let's set the record straight concerning what the League of Women Voters means when we say we are nonpartisan.

Thus began a letter drafted jointly by LWV Appleton-Fox Cities and LWV of Winnebago County in response to an article that appeared in The Post-Crescent. The full response may be found on our website; click on Op-Ed. LWVAFC Co-President Linda Bjella, and LWV of Winnebago County Vice President Posy Thurow authored the letter.

Upon receipt of the League response, The Post-Crescent added an Editor's Note to the original digital article clarifying the League's nonpartisan status. The newspaper also agreed to run an edited version of the piece as a Letter to the Editor in the Sunday, August 7 edition. Appearing alongside the League letter were a number of other letters calling out extremist politics. The digital version of these letters may be viewed online here.

Here is the edited text which appeared in Sunday's edition:

A recent article on 19th State Senate district candidate forums included Rachael Cabral-Guevara's comment about why she didn't participate in the League of Women Voters forum. "What I'm opposed to is the dishonest manner in which the LWV presents itself to voters," Cabral-Guevara said.

Let's set the record straight about what the League of Women Voters means when we say we're nonpartisan.

The League helps people exercise their right to vote by helping them register and providing nonpartisan, accurate candidate information. We never support or oppose any candidate or party. We stand on our founding principles to empower voters and defend democracy.

We study public-policy issues and arrive at positions that represent the consensus of our members, who come from all political parties or none.

Over our more-than-100-year history, our positions — which are on our websites — have occupied middle ground. In recent memory, we've been criticized for being too conservative. We haven't changed. Parties have become more polarized.

Our voter education tools are trusted by voters of all political stripes. <u>Vote411.org</u> is an award-winning source of unbiased candidate information. It provides a brief biography of candidates and their answers to questions, which we publish exactly as they submit. Unfortunately, some candidates don't submit responses — and voters lose.

In forums, we ask candidates the same questions. They get the same time to answer. When candidates refuse to participate in a forum, voters lose. We expect candidates to reach out to all voters in their districts, not just their base.

We encourage voters to use <u>Vote411.org</u> and our websites: <u>Iwvappletonfoxcities.org</u> and <u>Iwvwinnebago.org</u>. We invite all candidates to work with us to strengthen the democratic process.

League Commends City on New Position Restructure

Some good news in Appleton following their Climate Resiliency Task Force recommendations. The City has named Steve Schrage their first Project and Resiliency Manager. We will be submitting the following Letter to the Editor to the Post-Crescent:

"The League of Women Voters Appleton-Fox Cities commends the City of Appleton on their recent decision to retitle and expand Steve Schrage's position to Project and Resiliency Manager. This newly defined role in the City's Facilities Management department is definitely a step in the right direction following the City's 2021 Task Force on Climate Resiliency report.

Schrage has certifications in energy efficiency, renewable energy and sustainable development. He will serve as an adviser to department directors as the city works toward reducing its carbon footprint. This new focus gives Schrage the opportunity to research the creation of a climate change commission, another recommendation of the City's Climate Task Force which our League applauds.

Our local League studied climate issues in 2020 and 2021. We defined resilience as the ability to anticipate, prepare, and recover more quickly from climate events. Appleton's preparation for climate crises will benefit all of our citizens. Funding climate change preparedness is more fiscally responsible than repairing the increasingly frequent damage of severe weather.

Thank you to Mayor Jake Woodford, Director Dean Gazza, Director Jay Ratchman, and members of Appleton's Common Council for seeing the importance of focusing staff efforts and coordination on these critical issues."

League Urges Legislator Contacts Prior to Vote

The Inflation Reduction Act of 2022 is one of the most sweeping bills to address the climate crisis in our history. In advance of an expected Senate vote around August 7, we urged members to contact Senators Tammy Baldwin and Ron Johnson, and Representative Mike Gallagher with support for the Act.

Background: Among other important things in that bill, are proposed consumer incentives to relieve the high cost of energy and reduce their utility bills, as well as a fee on methane pollution. It's estimated that we'd achieve a 40% reduction of greenhouse gas emissions from 2005 levels by 2030. That is getting close to President Biden's 50% goal and our Paris Agreement Commitment. While this proposed bill doesn't include a price on carbon dioxide, the methane fee that would be included in this new law sets a new precedent for beginning to price emissions in the U.S., something the LWV advocates.

The LWVUS support position on market-based mechanisms to put a price on carbon pollution, was adopted 2018: "The League position is that each state or region will have different issues, different constituencies, and different challenges, so the path to reach a solution for pricing carbon can be very different for each. The position on carbon pricing of the League of Women Voters was approved at the 2018 national convention: The League of Women Voters stands united with and in support of efforts to price carbon emissions, whether cap and trade, carbon tax/fee, or another viable pricing mechanism. The LWV does not have a position on how the revenue generated is to be used. We do not espouse any single method of pricing carbon over another. We will evaluate all proposed methods based on their effectiveness to abate emissions and whether the method can be successfully implemented."


VOTER SERVICES: We're Back to Helping at Upcoming Events
