# Co-Presidents' Message: Housing, Voting Highlight Fall



After a summer hiatus that included a fun summer potluck picnic at 1000 Islands, we had a successful gathering in which many community members took a hard look at discrimination in the Fox Cities. We are beginning a flurry of activity as we approach another crucial election. League volunteers will be out and about doing what we do best: empowering voters by helping people register and providing trusted nonpartisan information on candidates.

We also begin an exciting series of fall programs. We will kick off our informational program series on September 19 with a virtual meeting to provide you with what you need to know about voting on November 8. We will hear from three of our local municipal clerks about the upcoming election and ballot rules changes, particularly returning absentee ballots.

In response to concerns about affordable housing raised at our last Lively Issues meeting, we will devote our October meeting to the new Outagamie County Housing Strategy. Look for more information about this program, which will be held at the Grand Chute Town Center Park Community Building on Monday, October 17.

We are excited to announce that we are teaming up with the Winnebago County League to provide a two-meeting series on the Wisconsin judicial system.

- On November 21, our League will offer an overview of Wisconsin's courts with an eye
  on the all-important Wisconsin Supreme Court election next spring.
- On December 5, the Winnebago League will offer the second part of our collaborative
- program with a look at what might be undermining and over-politicizing our courts.

More details on the time and place of these meetings will be announced soon, but please put these dates on your calendars.

To better reach as many people as possible, we hope that most of our programs this year can be inperson, and also potentially in a hybrid format, facilitated by our new technology, a new OWL device. We plan to use a variety of locations throughout Fox Cities. Finally, we are searching for accessible venues that provide good acoustics so all can hear and be heard, good accessibility and easy parking.

We hope you will plan on attending our annual Holiday Brunch (thwarted last year first by a snowstorm, then by rising Covid numbers). This year we are sure the weather will cooperate!

Mark your calendar for Saturday, December 10 at the Bubolz Nature Preserve and enjoy a great brunch and a program focusing on recent arrivals of immigrants and refugees in the Fox Valley.

## NONPARTISAN: Foundational to the League

EDITOR'S NOTE: In 2021, the League's nonpartisan status was called into question by a local radio host who claimed that the League's participation in a John Lewis For the People Act rally was evidence of the League's Democratic, liberal leanings.

Then-President Jeanne Roberts responded in support of the League's fundamental nonpartisan status, citing facts based on League positions which historically have drawn criticism from both sides of the political divide.

In light of today's political environment, particularly the temperature of mis- and disinformation, the Board felt that this response would be of interest to members, and further clarify the League's nonpartisan foundation.

The LWV has for over 100 years been an advocate of increased access to voting and voter rights. The National League worked with members of Congress to shape key pieces of the For the People Act, including expanding automatic voter registration, same day voter registration, and online voter registration. This includes increased access to voting for any eligible voter, not just voters of one party. This event was named in honor of civil rights icon John Lewis who worked his entire life on voting rights. The For the People Act is quite extensive. Some of the primary provisions include:

- Same-day voter registration for federal elections;
- Automatic voter registration for eligible citizens unless they choose to opt out;
- Expanded opportunities to vote by mail;
- Making Election Day a national holiday;
- Require states to allow on-line voter registration including updating information electronically (this is already allowed in Wisconsin);
- Establish criminal penalties for persons who "corruptly hinder, interfere with, or prevent another person from registering to vote" and for voter deception or intimidation;
- Allowing 16- and 17-year-olds to pre-register to vote in advance of their becoming 18. (17-year-olds are already able to do this in Wisconsin if they turn 18 before the next election);
- Prohibit the practice of voter-roll purges;
- Promote voting access for people with disabilities;
- Providing additional protections for military and overseas voters;
- Increased election security;

- Impose stricter limitations on foreign lobbying, require super PACs and other "dark money" organizations to disclose their donors;
- Restructure the Federal Election Commission to reduce partisan gridlock;
- Overturn Citizens United, in which the Supreme Court held that limits on independent political expenditures by corporations, labor unions, and other associations are unconstitutional;
- Require states to use independent commissions to draw congressional district lines;
- •Require the president and vice president, as well as presidential and vicepresidential candidates, to publicly disclose their previous ten years of income tax returns.

It is definitely unfortunate that some would consider ensuring one of our most fundamental constitutional rights by increasing voter rights and increased access to voting to be a partisan issue. The League takes voter suppression very seriously and sees the enacting of the For the People Act and restoring the Voting Rights Act as essential steps towards prevention of voter suppression. The League will continue to support all of these positions regardless of which party is putting them forward.

### **DEI: League Work Part of Larger Movement**

The big news for Diversity, Equity and Inclusion (DEI) is a well-attended event at Long Cheng Market on Monday August 29th. *Slights, Snubs and Insults: Uncover Evidence of Discrimination in the Fox Cities* was attended by about 45 people. The guest speakers were poignant and moving. Discussions were fruitful. To me, it felt like an important step had been taken in an ongoing journey.

It's important to recognize those who showed up. They were honest and brave, shared experiences, and talked about things we don't usually discuss. They included familiar (League) faces and new (but similar) faces: including community leaders, especially from Appleton Area School District (AASD). For many, it was their first time to the market and their first time hearing of its importance and aspirations for the Hmong community.

There are always ways to be better. My view is the more voices and perspectives at the table, the better the outcome. We relied on videos and invited speakers to set context. Looking ahead, collaborating with those with lived experiences (individual and organizations) will be essential from Day 1 for objectives and logistics, both of which are made easier with familiarity, as well as many hands and minds.

The key point from the event (for me) is recognizing the League's DEI work is part of a much bigger movement. There are many organizations and individuals in our community working in this space. What's important is what's next. The DEI committee needs to think big, strategically and concretely in how we move forward. My hope is that we get more voices at the table and prioritize organizational relationship building.

## PARTNERS: AAUW Tracks Equal Pay Days

The American Association of University Women (AAUW) has tenaciously been advocating for women and girls since 1881. They are one of the few organizations tracking pay equity. #### March 15 is Equal Pay Day

This symbolic day denotes how far into the year women must work to be paid what men were paid the previous year. This date is based on the latest U.S. Census figures showing that the average woman who works full time is paid on average just 83 percent of the typical man's pay. Started by the National Committee on Pay Equity (NCPE) in 1996, the goal of Equal Pay Day is to raise awareness about the gender wage gap. But because the pay gap varies significantly among different communities, other Equal Pay Days have been added to the calendar to reflect that fact that many women must work far longer into the year to catch up to men.

#### 2022 Equal Pay Days

This year, these dates have been designated using a new methodology: The COVID-19 pandemic pushed many women, especially women of color, into part-time or seasonal work, or out of the workforce all together. Because of this, past methods of calculating the wage gap fell short of accurately capturing the full picture. (Historically, Equal Pay Day has been calculated using data on full-time, year-round workers.) For 2022, the Equal Pay Day coalition has adopted a new, more inclusive methodology. This encompasses a broader cross-section of women, including those who work part time or seasonally, to represent a more accurate picture of how the gender pay gap impacts diverse communities

• Asian American, Native Hawaiian and Pacific Islander Women's Equal Pay Day is May 3.

- Asian American and Pacific Islander women are paid 75 cents for every dollar paid to white men. • LGBTQIA+ Equal Pay Awareness Day is June 15. Without enough data to make calculations, this day
- raises awareness about the wage gap experienced by LGBTQIA+ folks.
- Moms' Equal Pay Day is September 8. Moms are paid 58 cents for every dollar paid to dads.
- Black Women's Equal Pay Day is September 21. Black women are paid 58 cents for every dollar paid to white men.
- Native Women's Equal Pay Day is November 30. Native women are paid 50 cents for every dollar paid to white men.
- Latina's Equal Pay Day is December 8. Latinas are paid 49 cents for every dollar paid to white men.

These are the 24 words which SHOULD be the 28<sup>th</sup> Amendment to the U.S. Constitution. The Equal Rights Amendment was first proposed in 1923. In 1972, it finally passed in Congress and was sent to the states for ratification. In 2020, the 38<sup>th</sup> and final state ratified. So why is it STILL not part of the Constitution?

There are several legal challenges, but there are some concrete steps you can take to help finish the process of ratification.

The ERA Coalition has outlined <u>6 actions</u> that you can take right now to help get the ERA published. Put them on your list of things to do!
