

Since voters are already voting by absentee ballots, please help us right now by sharing information about these referendums with voters.

Appleton Area School District Referendums

Outagamie County Clean Water Advisory Referendum

"Should the State of Wisconsin establish a right to clean water to protect human health, the environment, and the diverse cultural and natural heritage of Wisconsin?"

LWV Appleton Fox Cities also encourages a YES vote on the Clean Water Referendum. We made a statement at the October 11 County Board meeting and have submitted the following Letter to the Editor of The Post-Crescent.

Editor, The Post-Crescent:

Outagamie County citizens will vote on this advisory referendum on November's ballot. The League of Women Voters Appleton-Fox Cities urges a "YES" vote on this question. During a recent deep-dive study of how climate change impacts our area, we were struck many times by the centrality of water issues. Human health and well-being, economic success, and environmental stability all depend on abundant, uncontaminated water resources. Nothing is more fundamental to well-being than clean water.

However, our study also revealed that we experience some troubling water quality issues in Wisconsin. From toxic algal blooms in Lake Winnebago, to contaminated drinking water, to nutrient loss from farm fields and more, clean water issues are of ever-increasing importance to our area. The advisory referendum will be an emphatic statement to our elected officials that they must act to improve and protect water. In doing so, they will improve the lives of all Wisconsin citizens and protect the natural heritage of clean water in our state.

We urge all Outagamie County voters to cast their ballot with our collective health and well-being in mind. Vote "YES" vote on the advisory referendum question to urge our State government toward greater emphasis on clean water as a basic right.

Earth Day | Election Edition

Finally, don't forget Earth Day | Election Edition on Saturday, October 22, from 12:30 to 2:30pm at the Pierce Park Pavilion. Join our League and our community partners, Citizens' Climate Lobby-Appleton/Fox Cities, ESTHER Environmental Justice Task Force, and PopEarth in keeping Earth Day a hot topic for voters. We will enjoy music by Christopher Gold; a keynote by Ligia Rivera, who cochaired the League's study on local climate resilience, and fun informational displays by local organizations. Then action shifts to a march across the Memorial Drive Bridge before heading back to Pierce Park.

DEMOCRACY IN ACTION: Award Nominations Welcome

Our League is currently seeking nominations for the 2022 Making Democracy Work Award, which will be presented at our Holiday Gathering on Saturday, December 10 at Bubolz Nature Preserve.

The Making Democracy Work Award honors those individuals (adult and youth under age 21) or organizations who have envisioned a way to improve the Fox Cities community and have inspired others to work with them to effect change. Nomination deadline is November 1.

The Making Democracy Work Award was developed in 2010 at the national League level. The signature award honors the civic work of individuals in their community as demonstrated through their professional work or volunteerism.

The award also has the potential to increase visibility of the League's contributions to the community and to highlight the value of League membership.

DEI News to Know

AAPI Presents "When the Emperor Was Divine" Author Julie Otsuka

On Sunday, October 16 at 4:00 p.m., the Asian American Pacific Islander Coalition of Wisconsin (AAPI Coalition of Wisconsin) presents a special virtual event with Julie Otsuka in conversation with Tom Ikeda. Otsuka is the author of the award-winning novel When the Emperor Was Divine, which tells the story about the incarceration of a Japanese American family during World War II.

In this webinar, Otsuka will be interviewed by Tom Ikeda, the founding director of Densho, an online archive and public history organization that has documented stories, since its founding in 1996, about Japanese Americans incarcerated during WWII. They will discuss the art of writing the novel itself as well as Otsuka and Ikeda family's experiences in the WWII camps.

The program also will focus on how K-12 teachers' professional judgement is being overruled by people who are uncomfortable with dealing with the truthful representation of our nation's history, particularly when told by authors of color. Asian American history is American History.

VOTING: Ramp-Up to Election Is Busy Time

Voter Services volunteers have been very busy! The two month period before elections is an important time to reach out to voters for registration, re-registering if they have moved, and generally providing information on voting municipalities, polling locations, ID needed for voting, absentee/early voting, what's on the ballot, and finding nonpartisan information (VOTE411).

We participated in the Appleton Farm Market, Latinofest and Head Start, as well as National Voter Registration Day with tables at Fox Valley Technical College, and the Medical and Dental Community Partnership facilities.

On Wednesdays from September through November 2, the League has a table in the entryway of the Appleton Public Library from 4:30-7:30 p.m. You may have seen the press coverage on this.

We also have been busy at the Appleton high schools (East, West, North and Central). A new member, Maggie McGinnis, is doing an outstanding job at Xavier getting students who turn 18 registered to vote. Check out her nonpartisan newsletter and podcasts at https://smartvoter.substack.com/

We also will be part of the UWO Fox Cities registration and voting promotion events as well as the Earth Day | Election Edition rally at Pierce Park on Oct. 22nd sponsored by the Citizen Climate Lobby. We are still looking for volunteers to staff the table.

We have been working with ESTHER, which received a grant for voter outreach. They are doing canvassing and we supplied door hangers. An ESTHER group has been trained by our League volunteer in Voter Registration, and they have been added to our volunteer list. Additionally, we collaborated with them on three postcard writing events (the last was October 13). LWVWI supplied the names for the postcards.

Information on Forums/Interviews:

The League is very serious regarding nonpartisanship and our policy does not allow us to have an "open chair" forum—meaning only one party is represented. Therefore, we did interviews for some of the candidates and posted them on VOTE411. The forum for Assembly District 56 with Dave Murphy and Patrick Hayden was recorded and is posted on our website. The Assembly District 57 Lee Snodgrass interview has been uploaded to VOTE411.

PROGRAMS: Housing Issues Top October Session

One of the things I love most about living in Wisconsin is experiencing all the seasons. I love that each season seems to sneak up on us. This time of the year, I love the eye-popping colors of the leaves! Isn't it gorgeous and we don't even have to drive somewhere else to see this miracle. Autumn brings the federal election followed by a series of holidays and holydays. Anyhow, I'm looking too far into the future.

On September 19 we had a program about the changes regarding Wisconsin voting procedure. We had a great group who joined that event ,and for those who missed it, here is the link to the recording.

Our October 17 program addresses Outagamie County housing issues and the county's response. Affordable, clean, and safe housing is a basic human right. Our League has a number of positions regarding housing. Some are embedded within our Climate Change positions as part of building sustainable and resilient communities. We also have housing issues as part of our Human Trafficking and Alternatives to Incarceration positions. Below are our clear and specific statements regarding housing.

HOUSING (1995)

- A. Advocate feasible programs for low income and special needs housing, to relieve the housing shortage.
- B. Support feasible transitional housing and related programs which encourage economic independence.
- C. Support regional coordination/collaboration of agencies addressing issues related to affordable, adequate housing.
- D. Encourage local and regional governments to actively pursue the development of adequate and affordable housing through regulation and comprehensive planning.
- E. Educate the community regarding the need for adequate, affordable housing.
- F. Support a housing ombudsman (independent, unbiased, well-informed and well-regarded member of the community), who would provide information on housing and investigate citizen housing complaints and recommend appropriate action.
