LIVELY ISSUES = Lively People + Lively Discussion

The only thing more exhilarating than a large group of concerned and engaged people getting together to talk about our community and its challenges, is to solve those challenges! Well, we can't solve all the challenges, but at least we identified a number of areas where our communities can use some positive energy.

On January 14, we held our annual Lively Issues gathering at Kaukauna Public Library. (Thank you Kaukauna Public Library for the wonderful space and gracious people!) There were more than 30 people listening, talking, discussing, and sharing information. After a few hours, we were able to see the fruits of our efforts.

It's essential for the Board to know what is important to our membership, and throughout the year, they will continue to look at the list generated. This helps us formulate program studies and educational programs, and helps the Action Committee and Observation Corps focus their attentions.

Ultimately, the Program Vice President presents the list along with a study proposal to the Board, which then considers the recommendations and decides what to present to the membership. At the Annual Meeting (May 20, 2023), we members vote on whether to undertake the proposed study. If you're interested in seeing the entire document, please contact Renee for a copy.

Issues were organized under three categories: Local Government, Natural Resources, and Social Policy. Here are the topics most frequently raised in these categories.





Local Government

- 1. Position reviews [through a DEI lens] There were at least six specific position statement areas identified throughout the day: law enforcement, local police protection, juvenile justice, parks and recreation, mental health, and local government organization. When grouped together, the review of current local positions had the most support for a study.
- 2. Transportation/ Regional Transportation Authority This issue included a variety of topics including Amtrak services to Appleton, extending area bus routes, and assessing community services for "walkability." [LWV WI

"Smart growth" positions cover these issues should we find a need to advocate.]

- **3. Opioid crisis** While we have mental/behavioral health positions and new health positions being proposed this May, none of them specifically address this crisis.
- **4. Park land usage** between public and private should be assessed. This issue stems from the current proposal to relocate the Trout Museum of Art tin the Ellen Kort Peace Park.
- 5. Welcoming communities (immigrants/migrants/refugees) Of special interest were policies or resolutions to county and state governments to allow undocumented to obtain driver licenses. [Please note that we can only advocate for local policies and local actions.]

Natural Resources

1. Water quantity is a growing concern even though we have many

strong positions regarding water quality. [LWV WI has a position on water quantity. It falls into the "Sufficient funding for state and federal agencies to monitor water quality and quantity through regular testing and have a legally defined mandate to act in upholding water standards" (page 57). "In 1985 the legislature adopted the Water Resources Conservation Act, supported by League, as a part of the Great Lakes states' strategy to conserve water and resist major water transfers out of the Great Lakes basin. League was involved in developing administrative rules and a state water quantity plan."]

2. Solid Waste, including food waste These issues also received a lot of consideration and votes. After discussion, it became clear that there are new technologies and policies regarding waste management that have come into play. This topic will probably lead to an education program in the coming year.

Social Policy

Social policies tended to have the most varied topics of discussion. Below are just a few issues.

- 1. Affordable housing Programs/incentives, and neighborhood revitalization once again led with the most votes. [We have numerous strong housing positions covering geography, affordability, and emergency management. Every year for the past three years we have had an education program regarding various aspects of our housing crisis and we probably will again in 2023. What will happen is that the Action Committee will continue to keep watch for and alert us on any policies or actions our local governments are taking regarding this topic.]
- 2. Cost of dependent care concern was voiced over child and senior care and the role that over regulation might play into this. (2 votes) [Education 2019 under the early childhood section E4 talks about affordable childcare but nothing regarding senior care. None of the positions discuss adult care.]
- 3. Low-income senior care facilities, quality and affordability also prompted a lot of discussion. [While this issue can be covered under current position statements, it is not specifically mentioned. This will probably be included within the housing education program.]
- **4. Dissemination of information to newcomers** Given the state of local journalism/press, how do newcomers become familiar with our communities? This is a new issue brought to light. Is there a way for the city to do this?
- Local News Coverage The breakdown of local news coverage and corporate ownership of newspapers is a rising concern. [We are offering an education program regarding this issue April 17, 2023. Look for announcements in March!]

Potential Education Programs as Springboards to Studies

- Solid Waste and Food Waste Disposal
- Law Enforcement Program to invite the new Appleton Chief of Police to help us better understand her priorities and concerns.
- Senior housing/assisted living for low income: What's going on with Calumet County? Hopefully we'll offer a joint program with LWV Winnebago County.
- Appleton Area Affordable Housing
- Broader Land Use Issues and how area developers and government agencies are looking forward.

Voter Guide Launches in Time for Primary

The League of Women Voters of Wisconsin launched its VOTE411.org voter guide for the Spring Primary Election. Voters across the state can find information about upcoming races including Wisconsin Supreme Court Justice, Special Election for Senate District 8, Circuit Court Judges and local races like town, village, city boards, and more.

This one-stop shop for statewide election information has tools—in both English and Spanish— to help Wisconsin voters navigate the voting process. These include candidate information, voter registration tools, polling place information and other helpful Election Day resources.

Voter guides are especially helpful for nonpartisan spring elections, as candidates on the ballot are not marked with any party affiliation. On VOTE411, voters can learn more about the responsibilities of these offices and each candidate's values.

Voting should be pleasant and simple. So head on over and get out to vote on February 21!
