President's Message: Refresh Awareness of League Positions

Have you taken a look at our local positions lately? They're easy to find on our <u>website</u>. Click on the "About Us" tab on the home page, then select "Policies and Positions" on the drop-down menu. You'll find a link to national, state, and local League positions. In sum, there's over a century of history there, but let's focus on just our local positions. What follows is a chronological summary of the major ones.

Our first official position dates from 1961*. We studied Appleton's city government that year. We expanded and updated that position in '65, '67, and '69.

In the 1970's our study committees were delving into regional planning, local and regional law enforcement, Outagamie County government, juvenile law enforcement and corrections, and the Appleton Public Library.

We took another look at Appleton's city government in 1980 as well as the Parks & Rec Dept. in '82. Other issues we explored in the 1980's were energy conservation, Outagamie County's Health and Human Services, public health, education (again), Outagamie County government (again), and annexation.

In the 1990's our positions further expanded to include recycling, town government, regional law enforcement, youth advocacy services, housing, billboard control, local transportation, the Fox River Corridor, and yet another study of both the Appleton Public Library and education.

There were a lot of folks thinking about a new PAC in 2000, and so was the League. The next year, we tackled PCB's. In '02 we studied alternatives to incarceration. In '03-'04 we developed positions on smart growth and regionalization, and in '08, we delved into mental health care.

In 2014, we took yet another look at the Appleton Public Library. In 2015 and '16, we studied human trafficking and land use planning. In 2019, we developed an updated education position.

Our most recent studies include Climate Change Preparedness and Resiliency in 2020-2021, and this year we approved a position on equity in health care.

Some of you will remember serving on some of those study committees, but some of you weren't even born when they were done. Taken together, it's an impressive legacy for our local League. Each position represents countless volunteer hours of research, interviews, study, and meetings. But how well do these positions speak to this current moment and the future?

Our study committee this year is examining all those positions through a DEI and Fox Cities regional lens. The goal is to identify the positions that require a new, updated study, those that can be tweaked, those that need no change, and those that should be archived. We are using three DEI questions from LWV US to guide our work and one that focuses on regionalism.

- 1. Who is involved in the process?
- 2. Who will be impacted?
- 3. What are the likely intended and unintended outcomes?
- 4. Could this position be relevant throughout the Fox Cities?

Take a look at our local positions, and try this exercise for yourself. Stay tuned for our study committee's recommendations at our Lively Issues meeting in January.

One element of ensuring that government is transparent and accountable to the citizens is following the actions of the governmental units. That's the role of the League's Observer Corps. Volunteers attend governmental meetings and report their actions to the League in an impartial way. They alert the League to emerging issues that warrant League attention.

Presence of League volunteers puts elected officials and staff on notice that their work needs to be transparent. When the League president speaks at public meetings, the statement is based on the League's well-researched positions.

League President Linda Bjella recently addressed the Outagamie County Board about its lack of virtual meetings that would enable more people to follow the proceedings, and at its budget hearing. Action Vice President Jan Quinlan followed the City of Appleton budget review sessions and addressed the mayor and Council on behalf of the League. 
