### President's Message: Period of Transitions Prompts Appeal

As our local League turns 85 this year, we find ourselves undergoing two big transitions.

### **Transition #1: Appleton to Appleton-Fox Cities**

In 2021, we officially became the League of Women Voters of Appleton-Fox Cities, greatly expanding our outreach. Consider the work of our Voter Service Team: In the past year, there were 15 tabling events featuring our new colorful spinning wheel which attracts far more people to our table. This gives us an opportunity to engage with people of all ages as they answer our civics questions. A new voter registration project at the DMV logged 190+ volunteer hours and assisted nearly 150 people with voting and registration questions. We sponsored candidate forums and interviews this spring that attracted large crowds and the recordings had more than 300 YouTube views. In addition, there were 142 new users of Vote411.

More than 100 people logged in to our two virtual Town Halls with Fox Cities legislators and 132 people viewed the recordings. Nearly 4,000 people visited our website, and our Facebook page reached more than 5,600. Our observers have fanned out beyond Appleton and Outagamie County and more local governments are being held accountable as a result.

We sponsored programs on Local Law Enforcement, Government Accountability and Transparency, Environmental Justice, and Senior Housing. We had 90 attendees at our Holiday Brunch at Bubolz which featured a panel discussion on the Freedom to Read.

#### Transition #2: a new membership system for LWV US

Beginning in January 2025, all dues will be collected by the LWV US and then divided: 33% to national, 47% to state, and 20% to local leagues. This means that we must rely on our spring finance drive to provide us with enough money to adequately fund our increasingly ambitious activities throughout the Fox Cities.

Despite the fact that we are an all-volunteer organization, we do incur significant expenses that are not covered by dues alone. By now you should have received our annual spring fund drive letter. You may be a bit shocked by our ambitious goal of \$10,000. However, thanks to a very generous matching-grant donation of \$5,000 from one of our members, your donations will be doubled this year.

Our greatest expense is for technology: website subscriptions, professional management, and security cost more than \$7,000 per year. We pay \$300 for our professional Zoom subscription. PayPal and

Square Space charge us about \$400 for on-line payments. Rent for our office adds up to \$4,200 annually. We have budgeted \$1,000 for monthly programs (room rental, honorariums) and \$3,000 for voter service. All local Leagues must now pay for their own liability insurance which was previously provided by the state League. Our policy costs about \$1,500 per year.

Members have an option to set up recurring donations by logging into their member account. This provides our League with sustaining monthly or quarterly income and allows you to spread out your donation throughout the year. Your investment in the League is an investment in our local community. Our quality of life improves when we have more informed and engaged citizens. And remember, all donations will be DOUBLED this year! — Linda

## ACTION: Get Ready for Consensus on Local Positions

At our May 23 Annual Meeting, members will vote on the consensus recommendations about our local support positions. If you've been following along during the year, you know that a 16-person study committee has been thoroughly reviewing these positions with an eye toward our League's regional expansion and also our commitment to diversity, equity, and inclusion.

#### Our March 18th consensus meeting made two recommendations:

1. Adopt a preamble to our LWV Appleton-Fox Cities support positions that can be used immediately following the annual meeting whenever our League takes advocacy. This preamble will expand our

focus to the entire Fox Cities region and also articulate our dedication to diversity, equity, inclusion, and respect for all our citizens.

2. Accept the committee's assessment for changes needed in our support positions. These changes range from cross-referencing to language changes to recommendations for new studies. Due to the detailed work of this year's study committee, the list is long and quite specific.

#### An important note about this consensus:

The precise changes to our support positions will be tackled by a task force *following* the annual meeting. This task force will use the assessment to update our entire local positions as recommended. They will present the specific changes to our Board and membership at a later date. That means our vote on May 18th will NOT include any specific changes to the local support positions beyond adoption of the preamble.

### PROGRAMS: Public Safety Is Recommended New Study

Our League seasonal change is marked by the approval of a new study and study review recommendations. These two issues are on the agenda for the **Annual Meeting** which is **May 23**, Thursday at 5:00.

Our February Lively Issues meeting generated great discussions regarding our current positions on Local Police Protection (1973) and Regional Law Enforcement (1994). We agreed to generate a new study for 2024-2025. Our recommendation is to study Public Safety, the scope of which may include law enforcement in relation to the following:

- Use of technology and surveillance
- Community interaction (e.g. mental health, school liaison, culture and diversity)
- Regional agency coordination
- Fire departments and emergency services
- Drug enforcement
- Equipment and weapons
- Data collection and public dissemination

Public safety includes a vast array of issues and agencies. The study scope will be as broad or as focused as the people willing to help with the work determine is feasible.


