A Constitutional Crisis?

US League Demands Congress Restore Order of Law

On February 14, 2025, the 105th anniversary of its founding, the League of Women Voters sent a letter to Congress to express its grave concern over the state of our nation. The letter was signed by each of the 50 state League presidents, and those of Washington, DC and Puerto Rico, representing over a million members. The League demanded that members of Congress honor their oaths of office, protect their constituents, uphold their powers under our Constitution, and oppose illegal Executive Orders by the President.

The following are excerpts from that letter:

President Trump's executive orders violate the law and encroach upon the authority of Congress as representatives of the American people. This administration has attempted to:

- End birthright citizenship for all persons born in the United States;
- Pause the distribution of federal funds already allocated to programs by Congress;
- Dismantle federal agencies such as the US Agency for International Development (USAID) and the Consumer Financial Protection Bureau which require notice to, and the input of, Congress before such actions can be taken;
- Allow private citizens, who have neither been elected or complied with the advice and consent requirement of the Senate, to access sensitive government systems; and
- Attempt to reduce the federal workforce through unorthodox means that deny them due process.

So far, we have seen limited action from members of Congress to assert its authority under Article I of the United States Constitution. The outcry by Americans speaking out against the impact of these Executive Orders, including those who voted for President Trump, should be all that is needed for Congress to stand in its authority, legislate on behalf of the American people, and restore stability to the country.

PRESIDENT'S MESSAGE: Another UnnecessaryReferendum

There will be another referendum question* on the April 1 ballot. Here is the wording:

Question: "PHOTOGRAPHIC IDENTIFICATION FOR VOTING. SHALL SECTION 1M OF ARTICLE III OF THE CONSTITUTION BE CREATED TO REQUIRE THAT VOTERS PRESENT VALID PHOTOGRAPHIC IDENTIFICATION VERIFYING THEIR IDENTITY IN ORDER TO VOTE IN ANY ELECTION, SUBJECT TO EXCEPTIONS WHICH MAY BE ESTABLISHED BY LAW?"

As an organization dedicated to advocating for voters, the League urges a NO vote on this ballot question. Here are some reasons why:

• Wisconsin already has one of the most restrictive voter ID laws in the country, and there is well documented evidence that some voters are disenfranchised by this requirement. I personally experienced this when working with senior voters last fall -- people who used walkers or wheelchairs, who were miles from the DMV office and had no way to get there. How could they update their expired

state ID's? Feeling defeated, some just gave up the idea of voting.

- A constitutional amendment is a long process: it must be passed by legislatures in two consecutive sessions in two different calendar years, then placed before the voters as a question on the ballot. As with all ballot questions, when approved by the voters, it becomes an amendment added to our state constitution. Once adopted, it cannot be easily changed.
- This would tie the hands of all future legislatures. With the rate that technology is changing, a voter ID law could quickly become antiquated. Legislators would not be able to respond nimbly to changes that may cause a security threat.
- The law that is currently on the books was passed through the normal legislative process, which the governor can either sign or veto. The proposed ballot question was passed as a joint resolution which is not subject to the governor's veto. Passing legislation this way upsets the balance of power between the governor and the legislature.
- Unlike legislation, a constitutional amendment is less vulnerable to differing interpretations by the courts which also diminishes the constitutional power of this branch of our government.
- And finally, let's not forget that Wisconsin elections are administered openly, fairly, and competently. We don't need an inflexible constitutional amendment to address a nonexistent problem.

Our purple state is always ranked high in voter turnout. In fact, in the November 5, 2024 election, Wisconsin achieved the highest voter turnout in the country at 76.9 %. We point to the convenience of the myvote.wi.gov website, our same-day voter registration, and the ease of requesting absentee ballots as examples of voter-friendly laws, but in fact, since 2010, Wisconsin's ranking in the "Cost of Voting Index" has fallen dramatically.

A recent article by Madeline Heim in the *Milwaukee Journal-Sentinel* noted that Wisconsin ranks 5th hardest state in the nation for voting in contrast to its ranking as 4th most accessible in 1996 on the "Cost of Voting Index". The article noted, "In addition to the strict voter ID law, Wisconsin has

stringent rules for voter registration drives, does not have automatic voter registration, does not have preregistration for young voters, does not allow all voters to join a permanent absentee ballot list, does not consider Election Day a public holiday and does require the signature of a witness on absentee ballots...

"The state's ranking also drops because it doesn't offer early voting...On the index, that's different from in-person absentee voting, which Wisconsin does have. True early voting functions similarly to voting on Election Day, with multiple sites and evening and weekend hours to cast a ballot, while inperson absentee voting can be more restricted..."

The job of empowering voters and fighting against further restrictions to ballot access is always a priority for the League's work now and in the future.

*This is the 5th ballot question since 2024, and there may be more to come. We could see proposed amendments to prohibit the closing of places of worship during a state of emergency, prohibit the governor from using a partial veto to raise taxes, and another that would end discrimination or preferential treatment based on race, sex, color, ethnicity, or national origin. Yet, proposals to allow citizen-initiated ballot measures which are possible in 26 other states have fallen on deaf ears on the legislature. In addition, legislators have limited local advisory referendums to only those that concern tax dollars.

2024 Ballot Questions

2024: Prohibit non-citizens from voting. APPROVED

2024: Prohibit any level of government in the state from applying or accepting non-governmental funds or equipment for election administration. APPROVED

2024: Provide that only election officials designated by law may administer elections. APPROVED

2024: Prohibit the legislature from delegating its power to appropriate money. DEFEATED

2024: Require legislative approval before the governor can expend federal money appropriated to the state. DEFEATED
