On Tuesday, March 25, our League jointly sponsored a press conference with the Winnebago County League to issue a call to action to Congress.






On Tuesday, March 25, our League jointly sponsored a press conference with the Winnebago County League to issue a call to action to Congress. Inspired by the February 14 LWV US letter to Congressional leaders, we wanted to take a public stand locally to show how seriously we believe our democracy is threatened.

Over the course of several Zoom sessions, we pulled this together in less than a week. We wrote our speeches and a joint letter to our Senators and Congressmen. We had postcards

printed with the League's "Oath to Democracy" to hand out to attendees so they could write to their representatives. We organized and rehearsed our presentations and networked with other local nonprofits. We invited the media to the Menasha Public Library at 10:00 a.m. and held our breath.

By the time the event started, we had set up three additional rows of chairs. Margy Davey, President of the Winnebago League, and I delivered our remarks to frequent spontaneous applause. And then we signed a joint letter to Senators Baldwin and Johnson, and Representatives Wied and Grothman from our two Leagues. All 200 postcards were taken by attendees.

### MESSAGE TO CONGRESS: Protect the Rule of Law

Good morning. My name is Linda Bjella and I am President of the League of Women Voters of Appleton-Fox Cities. Our League, together with the League of Women Voters of Winnebago County, have convened this news conference to issue a call to action to Fox Valley residents to contact their elected representatives in Congress. We are joined this morning by members of several other local nonpartisan organizations such as (AAUW, Esther Fox Valley, NOW, The Women's Action Coalition, and Fox Cities Advocates for Public Education...) This demonstrates the deep concern of hundreds of Fox Valley citizens over what we see as a crisis for our democracy.

On February 14, the 105th anniversary of the League's founding, the League of Women Voters of the United States, together with League presidents representing all 50 states, the District of

Columbia, and Puerto Rico, took the very unusual step of sending an urgent letter to all Congressional leaders. Writing on behalf of over a million League members, the letter demanded that Congress exercise its Article 1 Constitutional authority to "protect the rule of law, defend the Constitution, and end the overreach by the executive branch of the government."

Article I of the Constitution invests great power in the Congress, the branch of the government closest to the people. Congress is granted the power to create our laws, the power of the purse, and oversight over the other branches. Federal government agencies created by the Congress cannot be dismantled without the consent of Congress. Money appropriated by Congress cannot be unilaterally paused or impounded by the Executive. We demand that our Congressional representatives — Democrats, Republicans, and Independents honor their oaths and protect us, their constituents, from this breathtaking power grab by the Executive branch of the government.

Hello. I am Margy Davey, and I am President of the Winnebago County League of Women Voters.

In its letter, the US League cited the following executive actions:

-an attempt to end birthright citizenship in the United States in violation of the 14th Amendment

-the firing of 17 inspectors general without giving Congress the 30-day notice required by federal law

-an ongoing attempt to dismantle federal agencies such as USAID, the Consumer Protection Bureau, and the Department of Education, which require notice to and input of Congress prior to such actions

-allowing private citizens who have neither been elected nor subject to the advice and consent of the Senate, to access the private sensitive data of the American people

-an attempt to reduce the federal workforce indiscriminately without providing employees the due process to which they are entitled

While Congress, the Executive Branch, and the Courts each have equal and balanced powers within our constitutional system, it is us, the American people, who have the ultimate authority to protect our democracy. We must fight for it, and demand that our Congressional representatives uphold the rule of law and protect our Constitutional Republic.







## PROGRAMS: Combine Learning with Friendship

Programming provides an opportunity for LWVAFC members to meet one another face to face, and is an integral part of education. March offered an important in-person **consensus** discussion of local support positions led by Jan Quinlan, Action Vice President, an opportunity to discuss the Federal Judiciary, and a review of the LWVUS consensus questions led by President Linda Bjella. Member voices were heard with mostly strong support of the consensus questions.

April 14 will offer an inside look at **local education funding**, particularly for special education. "The Time is Now: Fund Public Schools in the Fox Cities" is a 25- minute slide presentation created by Fox Cities Advocates for Public Education, which will be presented by Jim Bowman and Patti Clark-Stojke, that describes the educational opportunity available to children in the Fox Cities and how public schools help them achieve success. "The Time is Now" also explains, however, that schools in the Fox Cities are undermined by inadequate funding in operations, special education and mental health.

Bowman coordinates Fox Cities Advocates for Public Education. The non-partisan, issue-oriented advocacy group focuses on Wisconsin's promise of a quality public education for every child. He served for 10 years on the school board of the Appleton Area School District.

Patti Clark-Stojke is an experienced Appleton Area School District Special Education teacher with a specialty in Speech Pathology. The two will be joined by Holly Burr, the district executive director of Finance following the AASD Board meeting, if time permits. The program takes place at Einstein Middle School Auditorium in Appleton from 6:30 to 8:00 p.m. Registration is requested but not necessary.
