

### President's Message: Power Mapping Our Skills





Wondering what the League of Women Voters is doing to defend democracy and human rights — when so much is in danger? The answer is **Unite & Rise 8.5**. This initiative started in May 2025 and joins all levels of the League to mobilize 8.5 million voters nationwide to oppose the threats to our rights, our rule of law, and the balance of power.

#### The Four Pillars of Unite & Rise 8.5

- 1. Legal & Policy Advocacy: Challenge unconstitutional actions through litigation, advocate for electoral integrity reforms at state and federal levels, fight voter suppression, and protect due process.
- 2. Public Mobilization & Coalition Building: Turn out millions for quick activations and longer-planned activist campaigns, uplift local voices, and partner with grassroots, national, and international organizations.
- 3. Civic Education & Engagement: Launch public awareness campaigns, expand voter registration and turnout efforts, host educational forums, connect policy to real-life impact, and equip people with tools to act.
- 4. Democracy Resilience: Build lasting infrastructure to protect democratic values and institutions for the long haul.

What is our local League doing to make Unite & Rise successful? This month we've recruited a Unite & Rise "League in Action" team. Led by Co-Captains Nancy Jones and Sue Abrahamson, this team will meet regularly and activate using LWVWI and LWVUS Unite & Rise 8.5 playbooks. Look for their article in this newsletter.

Our local League Board met July 29 for a working retreat where we "power-mapped" those community organizations with whom we might work on this mission. We identified scores of groups and began the task of mapping our local League's personal connections.

Our goal is to return power to the people. Unite & Rise 8.5 symbolizes hope during this dark time when all three branches of our US government have been subordinated to an autocracy. Please join us by taking our <u>Unite & Rise member survey</u> — and let us know how you will get involved in our campaign to bring back our democratic system.

### Unite & Rise 8.5: Campaign Includes Democracy Practice

The **Unite & Rise 8.5 Campaign** is the biggest mobilization of the League of Women Voters since the Women's Suffrage Movement over 100 years ago. This is an "all hands on deck" moment for members and allies, family, neighbors, and friends. The League, at every level, is curating opportunities for all of us to step up our civic engagement over the next 15 months.

Nationally, Unite & Rise 8.5 is a multifaceted campaign focusing on: Legal & Policy Advocacy; Public Mobilization & Coalition Building; Civic Education & Engagement; and Democracy Resilience. A series of micro-campaigns, each with a three-month duration, will keep the campaign up-to-date with new action opportunities. The current micro-campaign theme is Holding Power Accountable,

**LWVWI's campaign** will be guided by the following pillars —

- 1. Defend democracy and push back against rising authoritarianism and tyranny
- 2. Empower people to utilize their first amendment rights and stand in solidarity with those most vulnerable
- 3. Standing up to protect human rights including:
  - a. Protect voting rights
  - b. End mass deportation and to keep families and communities together
  - c. Protect reproductive rights
  - d. Protect LGBTQ+ rights
- 4. Lay the foundation for a more just democracy in Wisconsin

### Fair Maps: Community Hearings Inform Draft Proposal



In mid-July, Community Hearings for a Permanent Fair Maps Process were held in multiple areas to gather people's input on a long-term solution to prevent future gerrymandering beyond 2030. The hearings were held by the Wisconsin Fair Maps Coalition, which works to positively change the redistricting process in Wisconsin. Fox Cities residents were included in a session held at the Brown County Library.

### PROGRAMS: Step Into New Monthly Lineup with Recycling

The League is ready to launch an exciting program year, and how better to get on our feet than a meaningful walking tour to kick things off!



On **Monday, September 8** we will be touring the Tri- County Recycling Facility in Appleton at **11:30 a.m.** Note the different time of day. Jordan Hiller, Recycling and Solid Waste Program Coordinator, has offered the tour overview below, and has also created two tour options to accommodate our group. The inside tour can accommodate only 19 members, requires closed toed shoes and has many stairs along the way. The second and equally informative tour is a classroom tour to ensure we can serve our group completely. The tours will take place simultaneously, and last between 45 to 90 minutes.

Get ready to see recycling in action! A tour of the Tri-County Recycling Facility in Appleton offers a behind-the-scenes look at what happens to your recyclables after they leave the curb. You'll follow the journey of paper, cardboard, plastic bottles, and cans as they move through the high-tech sorting system.

Tours begin with an overview of the recycling process and safety guidelines, then we'll head into the observation areas overlooking the main sorting floor. From there, you'll see how materials are unloaded, sorted by size and type, separated using advanced equipment like spinning discs, air jets, and optical sorters, and finally compressed into bales ready for market.

Along the way, you'll learn about:

- The people and machines behind the sorting process
- Common mistakes in recycling (and how to avoid them)
- What happens to the materials after they leave the facility
- How your actions at home directly impact the quality of recycling

### **PUBLIC SAFETY: Avoid Incarceration by Social Intervention**

The Appleton-Fox Cities League of Women Voters Research Study on Public Safety is developing new advocacy positions on public safety. We are conducting research locally, to ensure we are advocating for the most impactful policy change. As promised, this is the second in our series of newsletter updates and action opportunities to keep you informed on special topics.

In July, we discussed the need to eliminate \_crimeless revocation and provided an opportunity to advocate through the rules process, since the governor and legislature are at an impasse over legislative solutions. This month, we would like to focus on prevention — avoiding incarceration by investing in early social intervention — specifically, how individuals can improve early literacy. (Crimeless revocation was detailed in the July issue of The Informed Voter.)

Breaking the complicated cycle that leads to incarceration in a <u>fundamentally biased system</u> will require complex action. Your talents are needed. Read on to learn more.

#### What can be done?

**Take Action** — The Appleton Area School District provides a great opportunity for individuals to make a difference by volunteering with the United For Reading Success (UFRS)

- High-quality and well-structured volunteer reading program for our youngest students
- Encourage children to enjoy books, support their efforts to learn to read, and to celebrate their successes
- Aligned with AASD's reading curriculum and instruction and is intended to build confidence and create lifelong readers and learners
- Includes all AASD elementary schools

#### So why is improving literacy important?

Literacy is a social justice/civil rights issue. If illiteracy were a public health issue, it would be considered an epidemic. Unlike cancer, illiteracy is solvable and we have the cure. It is the foundational tool on which all other essential skills are built. If we shared the tool of literacy equitably, and effectively, we could break the harsh social cycle of crime. Learn more from John Triscitti, Texas Library Association's 2014 Librarian of the Year, in his Ted Talk <a href="here">here</a>. According to <a href="here">JJ Parker</a>, a reading partner coordinator in New York, prioritizing reading proficiency for elementary school students, especially black and brown students, is one of the most important ways we can fight for social justice, equality, and equity for future generations.

#### Connection between literacy and incarceration

When adequate support does not exist for students who get left behind by a system that has been failing them in reading for decades, we doom many students to a school to prison pipeline.

- According to the National Assessment of Adult Literacy, 2/3 of students who cannot read proficiently by the end of the fourth grade will end up in jail or on welfare.
- 85% of all juveniles who interface with the juvenile court system are functionally low literate.
- Students who drop out of high school are 5 times more likely than high school graduates to be arrested in their lifetime.
- Students who drop out of high school are 63% more likely to be incarcerated than their peers with four-year college degrees.


Here are our selections for reading and discussion in August and coming months. Feel welcome to join us even if you have not read the books. The discussions are lively and informative.

### **VOTING RIGHTS: Appleton Mayor Honors Safe, Accessible Voting**

Celebration of the 60th Anniversary of the 1965 Voting Rights Act on August 6 took many forms. At the Capitol in Madison, LWVUS President Dianna Wynn held up League's steadfast allegiance to voting rights at a rally hosted by the state League. At Appleton's City Hall, Mayor Jake Woodford read this proclamation honoring our own community's commitment to fair, secure, and accessible elections and voting rights for all.

## **PROCLAMATION**



### Office of the Mayor

Whereas, on August 6,1965 President Lyndon B Johnson signed the Voting Rights Act of 1965 into law.

Whereas, the right to vote is a key building block of democracy ensuring that every U.S. citizen is given the right to help shape our country's future; and

Whereas, the City of Appleton acknowledges the extensive contributions of the many ordinary citizens who fought valiantly to end all race-based restrictions to the franchise. These include Appletonian Jim Zwerg who in 1961 traveled to Montgomery, Alabama, alongside Black activists including John Lewis, and was brutally attacked at the bus terminal; and

Whereas, Appleton civic groups like the League of Women Voters, American Association of University Women, Women's Action Coalition and others have persistently championed voter access through legal education initiatives, voter education drives, and on-the-ground registration efforts; and

Whereas, all residents are called upon to honor the spirit of the Voting Rights Act by registering to vote, engaging in the democratic process and advocating for the protection of voting rights for all; and

Whereas, the City of Appleton reaffirms its commitment to eliminating barriers to voting for all its citizens and reaffirms its commitment to promoting fair, secure and accessible elections.

Now therefore I, Jacob A. Woodford, Mayor of the City of Appleton, do hereby proclaim August 6, 2025, as the

in the City of Appleton, and encourage all residents to honor this historic milestone by exercising their right to vote.
