We will meet at the Library on Thursday, Sept 21st from 7 to 9 to continue and finish our consideration of the State Study of Voting Rights. We, along with the other local Leagues in the state, will be considering such questions as: Should felons be allowed to vote? (see our previous discussion), Should we continue to oppose Photo I.D.? Continue to support same day registration? What about absentee balloting and registration of deputies? Perhaps we can agree on most of these. (This is called consensus)

Report from the National LWV Convention

The League of Women Voters US held its 47th biennial national convention in Minneapolis, Minnesota. The 4 -day gathering gave League members from around the country the opportunity to celebrate the organization's accomplishments on civil liberties, election reform, judicial independence and global democracy and to discuss important public policy issues.

- Mary G. Wilson of Albuquerque, New Mexico was elected unanimously by the more than seven hundred delegates to a two-year term as the 17th president LWVUS.
- Adopt the LWVIL Death Penalty position by concurrence on the Convention floor. The position will read "The LWVUS supports the abolition of the death penalty."
- Adopt a three year study of immigration policies.
- Adopt a per member payment of \$26.30 for FY2006-2007 and \$26.80 for FY2007-2008.
- Adopt the position on the Citizens' Right to Vote be interpreted to affirm that LWVUS supports only voting systems that are designed so that:

- they employ a voter-verifiable paper ballot or other paper record, said paper being the official record of the voter's intent; and
- the voter can verify, either by eye or with the aid of suitable devices for those who have impaired vision, that the paper ballot/record accurately reflects his or her intent; and
- such verification takes place while the voter is still in the process of voting; and
- the paper ballot/record is used for audits and recounts; and
- the vote totals can be verified by an independent hand count of the paper ballot/record; and
- routine audits of the paper ballot/record in randomly selected precincts can be conducted in every election, and the results published by the jurisdiction.

Report from the State LWV Council Meeting

Deborah Cronmiller of Appleton was elected to serve as First Vice President of Administration for the League of Women Voters (LWV) of Wisconsin State Board. Over sixty members met for the League's biennial State Council Meeting on Sat., May 20th at the Cedarburg Cultural Center.

Council delegates elected a new slate of State Board members. Two-year terms were Debra Cronmiller from LWV Appleton -1st VP of Administration; Kathy Allen from LWV Ashland/Bayfield - VP/Membership; and Ellen Rosborough from LWV La Crosse Area -Treasurer. Julie Arneth from LWV Greater Green Bay to fill a one-year vacancy as Secretary. Also elected to two-year terms, were Diane Beres from LWV Ripon Area; Peggy Cox from LWV Neenah/Menasha; Diane Legomsky from LWV Greater Green Bay; and Linda Jorgenson from LWV Ashland/Bayfield Counties. Continuing on the Board until 2007 are President Melanie Ramey (LWV Dane County); Second VP/Program Marion Ruelle (LWV Wisconsin Rapids Area); Clare McArdle (LWV Dane County); Kathy Propp (LWV Oshkosh); Marilyn Boeldt (LWV Milwaukee County); Earnestine Moss (LWV Dane County); and Nancy Moore (LWV Stevens Point Area).

The luncheon keynote speaker was Jane Silberstein, U.W. Extension, who spoke on "The Ecomunicipality Movement in the Chequamegon Bay Area." Her work with the UW Extension focuses on helping communities, governments, nonprofits, businesses and institutions become more sustainable.

Council 2006 was hosted by the League of Women Voters of Ozaukee County. The next state-wide meeting of the League will be October 21st in Madison, WI for the annual Issues Briefing.


Legislative Committee Report to Council 2006 - In the last Legislative Session, the LWVWI Legislative Committee registered positions on 65 Senate and Assembly bills in addition to some budget subjects. The Legislative Committee wrote and submitted 47 statements to legislators and the press, as well as six letters to Governor Doyle. Executive Director, Andrea Kaminski presented LWVWI testimony on elections and voting issues to the U.S. Committee on house Administration. LWVWI also sent out 33 Action Alerts to urge members to contact their representatives or the Governor.
