hanks to our individual and collective efforts as the League of Women Voters, we had many legislative successes at the local, state and federal levels in 2007. At the state level, League of Women Voters of Wisconsin Executive Director Andrea

Kaminski says passing the state's biennial budget took a great deal of work this year. A few success stories from the Legislative Committee include:

- Passing the \$1 per pack cigarette tax that will help prevent kids from smoking and help adults quit, according to Pat Finder-Stone, LWV Greater Green Bay. She adds that this tax revenue will expand health care access for low-income residents through BadgerCare Plus.
- Darlene Wellner from LWV Manitowoc says the budget includes and 8.1 percent increase in special education funding and a 5 percent increase in foster care rates annually.

Questions for the Inmigration Study Consensus Process

For the first four questions, we are asked to rate each as follows: <u>"High Priority," "Lower Priority", "Disagree," or</u> <u>"No Consensus"</u>

- 1. Federal immigration laws should take into consideration criteria such as the following:
- a. Ethnic and Cultural Diversity
- b. Economic, Business and Service Employment Needs
- c. Environmental Impact Sustainability
- d. Family Reunification
- e. History of Criminal Activity
- f. Humanitarian Crises/Political Persecution in Home Countries
- g. Immigrant Characteristics (health and age)
- h. Rights of All Workers to Safe Working Conditions and Livable Wage
- i. Rights of Families to Remain Together
- j. Rights of all Individuals in US to Fair Treatment Under the Law (Fair Hearing, Right
- k. to Counsel, Right of Appeal, and Humane Treatment)
- 1. Education and Training

- 2. Unauthorized immigrants currently in the US should be treated as follows:
- a. Deport Unauthorized Immigrants
- b. Some Deported/Some Allowed to Earn Legal Adjustment of Status Based on Length of Residence in U.S.
- c. Some Deported/Some Allowed to Earn Legal Adjustment of Status Based on Needs of US Employers
- All Allowed to Earn Legal Adjustments of Status by Doing Things Such as Paying Taxes, Learning English, Studying Civics, Etc.
- e. If Deported, Assess Fines Before Possible Re-Entry
- f. Assess Fines Before Allowed To Earn Legal Adjustment of Status
- 3. Federal Immigration law should provide an efficient, expeditious system (with minimal or no backlogs) for legal entry into the US for immigrants who are:
- Immediate Family Members Joining Family Member Already Admitted for Legal Permanent Residence in the U.S.
- b. Entering the U.S. to Meet Labor Needs

- c. Entering the U.S. as Students
- d. Entering the U.S. because of Persecution in Home Country
- 4a. In order to deal more effectively with unauthorized immigrants, Federal immigration law should include: Social Security Card or other national ID card with se cure identifiers for ALL persons residing in the U.S.
- I4b. Federal immigration law dealing with unauthorized immigrants should be enforced by including:
- I. Physical Barriers (such as Fences) and Surveillance at Borders
- II. Increased Personnel at Land, Air, and Sea Entry Points
- III. More Effective Tracking of Persons with Non-Immigrant Visas until They Leave the Country

- VIII. Significant Fines Proportionate to Revenue for Employers Who Fail to Take
- IX. Adequate Steps to Verify Work Authorization of Employees

- 5. Federal immigration law should address and balance the long-term federal financial benefit from immigrants with the financial costs borne by states and local governments with large immigrant populations.
- 6. Federal immigration law should be coordinated with U.S. foreign policy to pro-actively help improve economies, education and job opportunities, and living conditions of nations with large emigrating populations.

Updates on the status of the PCB clean project

Dear Community Leader:

As a follow-up to my recent email summarizing 2007 work, I wanted to update you on the status of discussions with the EPA and DNR as it relates to finalizing the remediation effort in Little Lake Butte des Morts.

As I wrote a couple of weeks ago, we will be dredging and performing sand

cover operations again next year, beginning in spring 2008. As you know, next year will be the fifth year for our cleanup effort. I share that again because there was a recent order by the EPA forcing work to begin on other Fox River cleanup projects, and I want to be clear that the EPA order will not directly impact our project, as we continue to make very good progress in remediating PCB contaminated sediments in Little Lake Butte des Morts.

As I wrote a few weeks ago, we anticipate that our dredging and sand cover work will be completed next year and, at that time, we will begin to implement the final phase of the cleanup effort. The proposed plan for the final phase is to address the remaining sediment using an optimized remedy that takes into account what has been learned from the earlier stages of the project and the most current experience on how to remediate areas with lower PCB-concentration sediments.

We have been working with the EPA and DNR on the optimized remedy over the last few years, meeting the agencies' requirements while jointly devising a plan for final agency review and approval. The EPA and DNR will soon announce their conclusions on an optimized remedy. The EPA will then receive public comments and hold a public hearing on the plan. Finally, the plan will need to be approved by the agencies and reviewed by a federal judge, as part of an amended Consent Decree, for the project to be completed.

As stated in EPA's most recent *Fox River Current* (Fall 2007), the proposed plan will use three remediation methods: additional dredging, sand cover and armored capping. It would require additional dredging in shallow areas so that caps are only placed where the final water depth will be no less than 6 feet. It would also require sand cover be used over areas with low levels of PCB-contaminated sediment as well as over some areas previously dredged but with residual PCB concentrations. Lastly, armored caps – gravel and sand layers of minimum thickness – would be placed over remaining sediments to be addressed by the cleanup effort. These armored caps would keep sediment in place to ensure that it is not available to the biota (fish and invertebrates). Such a proposed plan would be consistent with the remedy approved for the downstream segments of the Fox River earlier this year. We support such an optimized remedy for the remaining sediment targeted in Little Lake Butte des Morts because we believe, based on science, engineering and experience, that it is as protective as dredging and is more cost effective.

This optimized remedy will allow us to achieve the goal of reducing fish exposure to PCBs in an accelerated timeframe and will be the final step in providing a cleaner lake. With this optimized remedy, our work in Little Lake Butte des Morts would likely be completed in 2009, with some remaining on-shore activities in 2010.

Again, the EPA will be sharing more details of the proposed optimized remedy with you and the general public in the coming days, but as always we want to keep you aware of any developments with our project. We hope you will review the proposed plan and agree it is the best final step to meeting the PCB reduction goals set by the EPA and DNR, and it will best provide for a cleaner Little Lake Butte des Morts in the timeliest manner.


