LETTER TO OUTAGAMIE COUNTY COUNTY BOARD FROM LEAGUE MEMBER

Dear Outagamie County Board Member:

I am writing to urge you to look closer at the county budget to find room for centralized mental health services for Outagamie County citizens.

The League of Women Voters-Appleton supports a 5-point platform on our mental health services. I would like to highlight just 2 of those.

- 1. We support a mental health care system which is community based and includes financial and geographic accessibility for residents of all ages. This system should include same day service availability and immediate care options insuring that no person in need of services would be turned away or made to wait. Appropriate on-going, affordable treatment options for all persons should be available regardless of one's ability to pay.
- 2. We support a mental health crisis care system that is responsive, well staffed and adequately supported.

In addition, the League of Women Voters-Appleton advocates for better alternatives to incarceration.

All too often, county residents suffering from mental health problems end up in a crisis situation. Jail is not the place for these individuals. Neither is a waiting list nor a neighboring county the place for them. Community based treatment - in addition to mental health crisis beds - is the answer. Centralized mental health services in Outagamie County is long overdue.

In the time you take to consider funding a new jail, I urge you to consider a better alternative for this money.

Please consider supporting centralized mental health services in Outagamie County instead of a new jail. The League of Women Voters will be awaiting your action.

Your thoughtful consideration and focused effort to address this need for centralized mental health services will benefit our neediest citizens and improve the quality of life for all in our county.



The membership, at the annual meeting, votes on recommendations that come from this grassroots meeting that we call *Lively Issues*.

State and National Studies

At the state level, the Election Administration study is in its second year. At the national level, the study on Immigration was completed and a position was adopted.

LWVUS Position on Immigration - Apr 01, 2008

The League of Women Voters believes that immigration policies should promote reunification of immediate families; meet the economic, business and employment needs of the United States; and be responsive to those facing political persecution or humanitarian crises. Provision should also be made for qualified persons to enter the U.S. on student visas. All persons should receive fair treatment under the law.
