Annual Meeting Information:

I limit most of my remarks to the annual meeting. You will be receiving a packet of materials which must reach the membership thirty days before the annual meeting per the bylaws. The packet will include:

1) Proposed Bylaw changes, 2) proposed changes to the Articles of Incorporation, 3)Nominating Committee's slate, and 4) the proposed Budget. These documents are for your perusal and will be voted upon at the annual meeting.

The major bylaw changes are due to the League's work toward becoming a 501 (c) (3) organization. The state league has been working for several years to gain nonprofit status for the league. It appears we are at the final stage of the process. The change in status requires that the local leagues amend their bylaws and those leagues who are incorporated must amend their articles of incorporation as well. Andrea Kaminski, Executive Director of the state league and Attorney Melissa Scholz have worked to change the local leagues' bylaws and articles to meet the requirements of the IRS.

The Appleton Board is also submitting two small changes for your consideration.

Your packet will include an explanation for the changes. The materials will arrive via email with a few through snail mail.

- Lively Issues Essentially a brainstorming session where any member can promote a topic with a local focus.
- Local Board Sifts the topics with the most support to be recommended (or not recommended) to the Annual Meeting for adoption.
- Annual Meeting Adopts one or more topics for study.
- President and Local Board Appoints a study committee.
- Study Committee Researches the topic, generates study materials for the membership, plans general meetings and facility tours (as appropriate), and invites speakers, frames discussion and consensus questions.
- Local Board Approves or modifies plans of the study committee.
- Membership Reads the study material, attends the meetings, and participates in the discussion and consensus.
- Study Committee Creates a position statement based on the consensus.
- Annual Meeting Adopts (or modifies) the position.

While every step is important, the most important is the participation of the Membership!

The League of Women Voters of Appleton Internet Communications Policy

This policy approved by the Board on 3/8/2011.

BACKGROUND

'Social media' is the term commonly given to websites and online tools which allow users to interact with each other by sharing information, opinions, knowledge and interests. Social media involves the building of communities or networks, encouraging participation and engagement. Social media can fundamentally change the way the League works. This is both a tremendous benefit and a serious responsibility for League members. The League of Women Voters of Appleton has the opportunity to create a prominent internet presence. The goals of our internet presence are to provide transparency, promote community awareness and attract new members.

The functions of administering the LWV website, Facebook page, newsletter, and email or other social media involve specific skills. Therefore the four roles may be assigned by the Board to individuals who demonstrate those skills and have knowledge of League principles.

POLICY

Anyone using social media on behalf of the LWV Appleton (League members or administrators of the League's social media) must have knowledge of LWV Appleton Positions and Non-Partisan Policy. Since internet posts may attract media attention and may be republished by other media, it is critical that all posts are correct and appropriate. Any questions about the appropriateness of a post must be cleared with the Appleton LWV President. Information may not be disclosed, nor commitments made on behalf of the League of Women Voters unless authorized by the LWV Appleton President or Board of Directors. This applies to all internet media administered by the LWV Appleton or by any other individual or organization.

The Board and the social media administrators must have ongoing current knowledge of LWV Appleton activities. If the administrator is not a Board member she/he must continually communicate with the Communications Director (a Board member) to make sure that both the Board and administrator have a two-way dialogue and feedback process concerning all activities and projects.

Guidelines for website:

- The LWV Appleton website does not have a locked webpage for members only.
- The website does not contain a member list that includes members' contact information.
- The website administrator owns the password to the administrator page.
- The website administrator is responsible for working with the vendor as needed.

Guidelines for Facebook:

- The LWV Facebook Administrator sets privacy settings to the benefit of the LWV Appleton.
- The LWV Facebook Administrator is required to have a personal Facebook account.
 The administrator owns the password for the LWV account.
- The LWV Appleton Facebook page is a non-profit organization page.

• The LWV Appleton Facebook page neither "likes" nor links to business pages, political candidates' pages, or any other partisan Facebook page.

Guidelines for newsletter:

• The newsletter is named "The Informed Voter" and is published on the LWV Appleton website, and distributed by email to League members, with exceptions approved by the Board. Exceptions are made for those members who do not have access to email. Postage is paid by the LWV Appleton.

Guidelines for email:

- The LWV Appleton e-mail is the responsibility of the LWV Secretary. League email is
 reviewed and addressed in a timely manner by the LWV Secretary and delegated to
 other Board members at the discretion of the Secretary. The email database of
 networking partners, members, and donors is maintained within the LWV email
 account and kept up to date by the LWV Secretary.
- The LWV Secretary owns the email password.

Guidelines for Administrators and all LWV Appleton Members:

- All internet posts are timely for the purposes of public education and action.
- All internet posts, articles or comments are factual and verifiable.
- All internet posts addressing community issues always support LWV Appleton Positions.
- Do not post contact information without that individual's permission.


Proposed Communications Committee:

• The LWV Appleton has a Communications Director on the Board of Directors. This position will be filled beginning the spring 2011 term. The Communications Director oversees all publicity efforts, including but not limited to Letters to the Editor, invitations, public education events, promotion of election forums, and other announcements. The Communications Director oversees the administration of the LWV Facebook, e-mail, Newsletter, and website, as well as any other potential social media to be used By LWV Appleton. The Board President and the administrators in charge of the LWV website, email, newsletter, and Facebook page are members of the Communication Committee chaired by the Communications Director. The purpose of the committee is to enhance League communications in the electronic media, to educate the public on civic issues, and to promote membership.

Appleton City Council – approving police and fire contracts, moving ahead with making the city clerk's position appointed (League supports), preserving the old water plant site as parkland (League supports), and attempting to put together a policy for parade viewing along College Avenue which everyone can agree

Outagamie County Board – working on a request for use of county –owned land for developing a housing complex for FVTC students and hearing a report by the local committee wishing to build an exhibition center in downtown Appleton that would involve the use of a county-owned parking lot. League members should find all these meetings interesting. Try to attend whenever possible.
