Voter Registration Assistance

Candidate Forums

District 3 includes the eastern portions of the Fox Valley—Kimberly, Little Chute, Combined Locks, Buchanan, Harrison, and parts of Appleton and Menasha. This Candidates Forum will be held on Monday October 29 at Liberty Hall from 7:00-8:30 pm. Candidates Kole Oswald, Al Ott (incumbent), and Josh Young are invited to participate.

District 56 extends from northern parts of Appleton through Grand Chute, Greenville, and into Winnebago county west of the Valley. The Candidates Forum for this district will be held on Tuesday October 30 at the Bordini Center from 7:00-8:30 pm. Candidates David Murphy and Richard Schoenbohm will attend.

Voter Turnout

During this election year, LWV reminds you of the importance of voter turnout. The US historically has a very low percentage of voter turnout among eligible voters, typically just over 60% during a presidential election year. Turnout is even lower during a mid-term election, around 45%. And, these numbers are truly abysmal in comparison to other democracies: The US typically is in the bottom quartile or worse of any list of countries for % Voter turnout. Indeed, some countries require citizens to vote, thus achieving over 96% turnout.

Interestingly, among <u>registered</u> voters in the US, the turnout percentage is much higher: around 95%. This statistic emphasizes the value in helping voters to register, hopefully converting those that are "eligible" to "committed" voters!

Issue Briefing, Saturday, October 14, 2012 Madison, WI

It was a packed day of information. We heard from Helen Marks Dicks, Associate Director for State Advocacy, AARP-WI, on state and federal issues on healthcare. She stated that the Affordable Health Care Act will not be repealed...that repealing a law is extremely difficult to accomplish. But, she said, stops, delays and other steps will be used to ambush it. She predicts a spring war over Medicare, Medicaid and ACA. AARP is setting up teleactivists all over the state to respond to legislation that would be detrimental to Medicaid, the area she is most worried about.

Elizabeth Wheeler, Staff Attorney for Clean Wisconsin gave us information on mining that raised our concerns over keeping Wisconsin beautiful and environmentally safe. Wisconsin has very desirable sand that companies want to use to extract natural gas found in underground formations. The process is known as*fracking. Here in Wisconsin, we are dealing with sand mining. Wisconsin has seen an increase of sand mines, from 60 to 87 in 10 months. Ms. Wheeler warns us that there are no real state regulations for sand mining in Wisconsin. There is concern over harm to our environment as the number of these mines increase.

Joel Rogers, professor of law, political science, public affairs and sociology at UW-Madison and Director of Center on Wisconsin Strategy (COWS) spoke about Wisconsin's economy. The employment picture is bleak, but he offered ideas for dealing with the economy. He recommended smart growth-building up and out so that infrastructure use can be maximized and that manufacturing should compete on productivity and quality, not just on price.

Elizabeth McNamara, United States League President, delivered a rousing message. The US League is working across our nation to help states give voice in our fight to preserve Democracy. Elizabeth states that there are two tenets paramount to Democracy, THE RIGHT TO FREE SPEECH and THE RIGHT TO VOTE. She explains that the Supreme Court ruling in Citizens vs. United sets the bar very high preserving free speech. Not so with Voting Rights. The Supreme Court is setting the bar very low regarding the voter's rights. This is of great concern and puts the League on the front lines across our nation to fight for our citizens' basic right to vote.

Melanie Ramey, League of Women Voters of Wisconsin State President, spoke on the status of the Voter ID lawsuit. It is in the Appeals Court. Here is the message I want to share with our Appleton League Members.....Melanie said that when the state league decided to bring forth the lawsuit against the State of Wisconsin, there was no money to do this. Melanie stated that they went ahead knowing it was the RIGHT THING TO DO with the hopes that the money would come from those who care about the right to vote. The money came...Melanie said they received \$190,000. We care in Wisconsin. That amount of money is not uncommon for lawsuits. But, now that the lawsuit is in the Appeals Court, Melanie reports that the state needs another \$5,000. She threatened (with her usual coyness) to lock the doors on us until we handed over a check. ^{*} Hydraulic Fracturing (fracking). The term refers to the act of using high powered pumping equipment to force water, sand and proprietary mixtures of chemicals deep into the Earth's crust with extreme pressure in an attempt to literally shatter (fracture) formations of shale, a type of rock, and in doing so liberate natural gas trapped in the rock. Other high powered and very complex equipment then collects both the fracking solution and any freed natural gas at the surface.
