#### Voter Registration Assistance

Thanks to the dedicated volunteers for Voter Service, we collectively helped 132 voters to register prior to Election Day. These included new young voters, underprivileged voters at the Community Health Clinics, and many college students. We conducted a total of 17 VR Assistance sessions at 10 different locations.

#### Candidate Forums

LWV-Appleton held two candidate forums for the 3<sup>rd</sup> and 56<sup>th</sup> WI Assembly Districts where the audience members were able to ask questions of the candidates for 90 minutes. Both forums were well-run with thoughtful questions and a civil and respectful tone from all involved. Thanks to Kole Oswald and Josh Young in the 3<sup>rd</sup> District, and David Murphy and Richard Schoenbohm in the 56<sup>th</sup> District for their participation. We were disappointed that the incumbent for the 3<sup>rd</sup> District, Al Ott, was not able to join us.

#### Poll Observers

For the Fall election, LWV-WI had a total of 290 poll observers across the state including 8 here in Appleton. Although for the most part the observers in Appleton found that the polling places ran smoothly, we were able to document eligible voters being turned away due to lack of acceptable Proof of Residence, mostly students and residents who had recently moved but not changed their Driver's License yet. We also found some poll workers asking for a Photo ID in order to register to vote, which is not within the law. These and more irregularities were noted and passed on to LWV-WI who will compile the data and share with the GAB (Government Accountability Board, who oversees elections) in order to seek corrective action in the future.

#### Updating the LWV Position on the Appleton Public Library

#### Local Program for 2012-13

The local program for this year is to update our library positions based on a study of current technology and needs so that we can take informed action when an expanded library is again proposed and/or a library referendum occurs. The study will take place over 2 years and will include a review of current Appleton League positions (last updated in 1992), extensive information about past library planning processes and building studies, and how to create a 21<sup>st</sup> century library.
